Pursuant to Article 11, Paragraph 2, item 3 of the Law on Higher Education ("Official Gazette of Montenegro", no. 44/14, 52/14, 47/15, 40/16, 42/17, 71/17, 55/18 and 3/19), the Council for Higher Education on session held on April 16th 2019, issued the

CONDITIONS AND CRITERIA FOR PROMOTION TOACADEMIC TITLES

I BASIC PROVISIONS

Article 1

This Act defines terms and conditions for promotion to academic titles at Higher Education institutions.

Article 2

The academic titles are:

1) Full Professor,

2) Associate Professor,

3) Assistant Professor.

4) Teacher at a Higher Education Institution and

5) Lecturer at a Higher Education Institution

II CONDITIONS AND CRITERIA FOR PROMOTION INTO ACADEMIC TITLES

Article 3

Entities who meet requirements stipulated by the Law on Higher Education and this Act can be promoted to academic titles.

Article 4

Into academic title shall be promoted a person who:

- 1) holds a PhD in philosophy for the field of promotion, i.e. higher education for artistic courses and courses related for them on the faculty and academy for fine, applied, music, dramatic arts and architecture (hereinafter: artistic discipline);
- 2) acquired tested pedagogical skills, defined by the Council of organisational unit of the highest number of course lessons, or field of the competition announced;
- 3) meets requirements for promotion into title for an adequate scientific, or artistic discipline with international comparability, in accordance with this Act;
- 4) has recognised artistic works, for disciplines of art.

1. CONDITIONS AND CRITERIA FOR RELATED SCIENTIFIC/ARTISTIC DISCIPLINE

Article 5

As a criterion for election, i.e. re-promotion into academic title a candidate's scientific or

artistic, pedagogical and professional activity shall be taken into consideration.

Bibliographic value of scientific, expertise, artistic, pedagogical achievements of a candidate shall be assessed qualitatively and quantitatively (Annex 1, Annex 2, Annex 3 and Annex 4).

Article 6

Person being promoted into academic title in related scientific fields shall meet the following qualitative criterion:

Scientific and research results of the candidate are published in scientific journals from citation lists or bases of scientific papers SCI/SCIE/SSCI/A&HCI (categories Q1, Q2, Q3 and Q4, Annex 1).

2. QUALITATIVE EVALUATION OF BIBLIOGRAPHY

Article 7

Science and research results of the candidate referred to in Article 6 of this Act are evaluated for specific fields by number of points, as follows:

A) The Field of Natural-Mathematical, Technological, Medical and Agricultural Sciencesand Architecture

- 1) In order to be promoted into title of Assistant Professor, a person shall have:
- minimum 8 points for papers published in renowned journals from categories Q1, Q2,
 Q3 and Q4 (number of points in Q1+Q2+Q3+Q4>_8),
- minimum 15 points in total from science and research activity.
- 2) In order to be promoted into title of Associate Professor, a person shall have:
- minimum 8 points (after promotion) for papers published in renowned journals from categories Q1, Q2, Q3 and Q4 (number of points in Q1+Q2+Q3+Q4>_16),
- minimum 15 points in total (after promotion) from science and research activity.
- 3) In order to be promoted into title of Full Professor, a person shall have:
- minimum 16 points (after promotion) for papers published in renowned journals from categories Q1, Q2, Q3 and Q4 (number of points in Q1+Q2+Q3+Q4>_16),
- minimum 25 points in total (after promotion) from science and research activity.

B) The field of social and humanistic sciences

1) In order to be promoted into title of Assistant Professor, a person shall have:

- minimum 8 points for papers published in renowned journals from categories Q1, Q2, Q3 and Q4 (number of points K* (Q1+Q2+Q3+Q4) >_8),
- minimum 15 points in total from science and research activity
- 2) In order to be promoted into title of Associate Professor, a person shall have:
 - minimum 8 points (after promotion) for papers published in renowned journals from categories Q1, Q2, Q3 and Q4 (number of points K* (Q1+Q2+Q3+Q4) >_8),
 - minimum 15 points in total (after promotion) from science and research activity.

3) In order to be promoted into title of Full Professor, a person shall have:

- minimum 16 points (after promotion) for papers published in renowned journals from categories Q1, Q2, Q3 and Q4 (number of points K* (Q1+Q2+Q3+Q4)>_16),
- minimum 25 points in total (after promotion) from science and research activity.

When giving points to publications in categories Q1, Q2, Q3, Q4 for social and humanistic sciences the hardness coefficient K=1.5 is applied (Annex 1).

C) Filed of Arts

- 1) In order to be promoted into title of Assistant Professor, a person shall have:
- minimum 15 points from the field of arts work,
- minimum 10 points from the field of arts must be achieved through two representative and recognized references in narrower artistic filed of promotion (categories U1 and U2).
- 2) In order to be promoted into title of Associate Professor, a person shall have:
- minimum 30 points from the field of arts work,
- minimum 15 points from the field of arts must be achieved through two representative and recognized references in narrower artistic filed of promotion (categories U1 and U2),
- minimum 6 points in pedagogical skills, after promotion into title.
- 3) In order to be promoted into title of Full Professor, a person shall have:
- minimum 50 points from the field of arts,
- minimum 30 points from the field of artistic work shall be achieved through minimum three representational references that present exquisite artistic works influential on development of culture and art in narrower artistic field of promotion (U1 and U2),
- Minimum 10 points from pedagogical skills after promotion into Associate Professor.

Article 8

Authorship in scientific papers is scored so that first author is given a full number of foreseen points for bibliographical unit, while other authors, conditioned that number of authors is not higher than 5, divided by number equivalent with ordinal position of the author.

If first author is not at the same time the leading author of a paper, the evidence on leading authorship is needed (written statement of the first and other authors). In this case, leading author gets full number of points for bibliographic unit (as it is on the first position) and points to the rest of authors are given in accordance with the changed position.

For publications with number of authors higher than 5, authorship is scored in a way so that total number of points for publications is divided by total number of authors (for all authors including the first one).

Publications in scientific journals with disputable reputation and inadequate review (e.g. journals from predatory lists), as well as frequent publication in the same journal that is disproportionate to the number of publications of candidates in other journals (i.e. in cases where the impartiality of the journal editorial team is suspected), shall be further analyzed in order to be excluded from consideration when evaluating the candidate's contribution by the expert body or body of the Senate competent for scientific issues. In these cases, the author shall submit additional documentation to the expert body or body of the Senate competent for scientific issues: confirmation of sending the paper, decision of the editor together with the comments of reviewers and the like.

Article 10

A person who has affirmed oneself in the profession, i.e. the field for which is being elected, shall be promoted to a high school lecturer title.

It is considered that a candidate for a high school lecturer meets the condition referred to in paragraph 1 of this Article if he / she achieves a cumulative minimum of 5 points in evaluation of published papers.

Article 11

Into title of a higher school professor shall be promoted a person who:

- has professional papers proving affirmation of the candidate in the field for which is being elected,

- has an appropriate bibliography that includes papers and achievements that the profession recognizes as an appropriate way of presentation in the field for which it is chosen, and

- has a positive assessment of pedagogical work for the previous election period.

The candidate for a professor of a higher vocational school should achieve a cumulative minimum of 10 points based on published papers, of which at least 5 points after defense of the doctoral dissertation.

Equivalents for Evaluation of Bibliography

Article 12

Exceptionally, when evaluating bibliographic references for candidates being promoted to academic titles who do not meet the requirements concerning criteria for papers from categories Q1, Q2, Q3 and Q4 (listed in Article 7), it is possible to apply one of the following equivalences:

- 1) M1: Author's scientific monograph published by a renowned international publisher of scientific literature can be equivalent to one paper in a renowned journal (Q1 category);
- 2) M2: A chapter in a monograph published by a renowned international publisher of scientific literature can be equivalent to a single paper in a renowned journal (Q3 category);
- 3) R1: Editorial board in a Q1 journal may be equivalent to working in a Q1 journal, and editorial in a Q2 journal may be equivalent to working in a Q2 journal;
- 4) I1: International patent (EU patents, US patents) can be equivalent to one paper in a journal from Q3 category;

5) A paper published in a journal from a list determined by the Ministry of Education may be equivalent to one paper in a Q4 category journal.

Article 13

When applying the equivalence referred to in Article 12 of this Act, authorship of scientific papers shall be scored in accordance with Article 8 of this Act.

The candidate may use for equivalence only one of the categories listed in Article 12 of this Act and only one contribution from that category may be equivalent to paper in related journal.

III EVALUATION OF PEDAGOGICAL COMPETENCE

Article 14

When evaluating pedagogical competences of a candidate, the selection criteria are:

- Scope and content of knowledge about the field in which the candidate performs pedagogical work;

- Ability for modern organization of educational work and success in conducting lectures, exercises, seminars, consultations and exams;

- Professional, pedagogical and methodological value of scientific papers, textbooks and manuals;

- Mentoring in preparation of graduate, specialist, master's and doctoral theses;
- Evaluation of overall pedagogical work.

Article 15

Minimum number of points for pedagogical activity of candidates who are promoted to titles of associate and full professor:

- Minimum 6 points in total in pedagogical skills for promotion to title of associate professor (in classification bibliography a complete pedagogical activity of the candidate is stated),

- Minimum 10 points in total in pedagogical skills for promotion to title of full professor (a complete bibliographic activity of the candidate is stated in the classification bibliography).

IV TRANSITIONAL AND FINAL PROVISIONS

Article 16

Interpretation of provisions of this Act shall be given by the Higher Education Council.

Article 17

Procedures for promotion into academic titles initiated before this Act comes into force of will be completed in accordance with the Criteria on Conditions and Criteria for Promotion to Academic Titles, number: 05-1-107 / 2016 from September 9th 2016, i.e. in accordance with the Act provided that it is more favorable for the candidate.

Article 18

On the day this act enters into force, the Criteria on Conditions and Criteria for Election to Academic Titles, number: 05-1-107 / 2016 of September 9, 2016, shall cease to be valid.

Article 19

This Act shall come into force on the day of publishing on internet page of the Higher Education Council.

Status of the journal is assessed at the time of publication of the candidate's paper.
