Predmet: Mišljenje Odbora za doktorske studije o PD obrascu kandidatkinje mr Milene Aćimić Remiković

Poštovani članovi Komisije,

Odbor za doktorske studije je na sjednici održanoj 25. 2. 2022. god. razmatrao dostavljeni PD obrazac kandidatkinje mr Milene Aćimić Remiković, odnosno Odluku Vijeća Pravnog fakulteta broj 04-2088, od 14.12.2021. g., kojom se daje predlog za imenovanje Komisije za ocjenu prijave doktorske disertacije mr Milene Aćimić Remiković pod nazivom: *Rodna ravnopravnost: Međunarodno-pravni temelji ženskih prava sa posebnim osvrtom na Crnu Goru.*

U skladu sa članom 34 Pravila doktorskih studija (Bilten UCG, br. 513), Odbor za doktorske studije ima pravo da iznese komentare, primjedbe, preporuke na sadržaj prijave doktorske disertacije, o kojima će se izjasniti Komisija za ocjenu prijave doktorske disertacije, kandidat i mentor.

U toku rasprave o predmetnom predlogu, Odbor je jednoglasno konstatovao (od ukupno 11 članova Odbora, 8 je bilo prisutno) da je potrebno razmotriti sledeće sugestije i stavove Odbora:

- 1) Uvidom u bibliografiju predloženih članova Komisije za ocjenu prijave disertacije, ne može se utvrditi da su se predložena dva člana Komisije konkretno bavili temom ženskih prava, istaknutom u samom nazivu teme. U slučaju da se tumači u širem smislu, međunarodno pravo, čiji dio su ljudska prava, a čiji dio su ženska prava, predloženi članovi Komisije bi ispunjavali kriterijume, ali je pokrenuta diskusija da, ukoliko se kao oblast posmatraju ženska prava, u tom slučaju se može utvrditi da se prof. dr Nebojša Vučinić i prof. dr Aneta Spaić njima nisu bavili u svom naučnom radu.

Stoga, Odbor predlaže da se razmotri imenovanje (više) članova koji u svojoj bibliografiji imaju radove na temu rodne ravnopravnosti i ženskih prava.

- 2) Konstatovano je da je hipoteza široka, nejasna i nepotpuna: „Crna Gora je napredovala u uspostavljanju pravnog okvira koji omogućava postizanje standarda rodne ravnopravnosti.“ Postavlja se pitanje u odnosu na šta i/ili u odnosu na kada je Crna Gora napredovala? U samoj prijavi je prethodno, kao činjenica, već navedeno da je „mnogo urađeno“ na tom planu, te je pitanje da li postoji potreba za disertacijom kako bi se utvrdio sam po sebi napredak pravnog okvira (koji je, recimo, u odnosu na jednopartijski nedemokratski sistem, i u toku procesa napretka u evropskim integracijama i pristupanja euroatlantskim integracijama sam po sebi jasan), bez njegovog preciznijeg definisanja.
- 3) U sklopu odjeljka „Pregled istraživanja“ nisu data dosadašnja istraživanja, koja su polazište za predmetnu doktorsku disertaciju, već nacrt kako bi disertacija trebalo da izgleda, što (u znatno kraćem obimu) pripada odjeljku „Materijali, metode i plan istraživanja“. „Pregled istraživanja“, u stvari, treba da prikaže šta je prije ovog dokorskog istraživanja urađeno po tom pitanju i koji je prostor da ovo istraživanje da doprinos predmetnoj temi. Umjesto toga su navedeni opisi planiranih poglavlja, koji ističu deskriptivnu, a ne analitičku dimenziju rada. Čak i u poglavlju *Empirijski okvir: Istraživanja o ženskim pravima* nije predviđeno sopstveno istraživanje doktoranda, već interpretacija ranijih istraživanja. Stoga se nameće pitanje da li je cilj rada analiza norme ili eventualnog jaza između normativnog i empirijskog, te bi shodno tome možda pojedina poglavlja disertacije mogla i/ili trebala biti modifikovana/eliminirana.
- 4) Očekivani naučni doprinos nije jasno istaknut.
- 5) Odbor predlaže i da se razmotri korigovanje naziva disertacije, tako što bi bio izostavljen dio „Rodna ravnopravnost“.

Gornje stavove i sugestije Odbora vam dostavljamo prije imenovanja Komslije za ocjenu prijave doktorske disertacije, budući da se jedna stavka odnosi i na sastav te komisije. S obzirom da Odbor nije izričitog stava da je potrebno promijeniti predloženi sastav komisije, ukoliko Pravni fakultet smatra da je sastav komisije valjan, Odbor će podržati predlog Pravnog fakulteta uz odgovarajuće obrazloženje. Ostale stavke, sa kojima vas upoznajemo već sada, će biti upućene na izjašnjenje Komisiji za ocjenu prijave doktorske disertacije, kandidatu i mentoru, ukoliko PD obrazac ostane neizmijenjen.

Obrazloženje teme

Naziv disertacije **“Rodna ravnopravnost i jurisprudencija: Korišćenje međunarodnih rodni standarda za ostvarivnje ženskih prava u crnogorskoj legislativi i sudskoj praksi”** upućuje na analizu rodne ravnopravnosti sa aspekta dva referentna pravna okvira - međunarodnog i domaćeg, kao i na evaluaciju implementacije relevantnih međunarodnih standarda u crnogorski pravni sistem, sa posebnim osvrtom na jurisprudenciju međunarodnih i nacionalnih sudova.

U patrijarhalnoj kulturi kakva je crnogorska, zastupljene su predrasude i pogrešna uvjerenja o statusu žena ne samo u društvu već i u privatnom životu. Žene u Crnoj Gori su još uvijek neravnopravne i problemi za postizanje rodne ravnopravnosti tek treba da se rješavaju u svojim različitim pojavnim oblicima. Indeks rodne ravnopravnosti je prvi put izračunat u Crnoj Gori 2019. godine sa vrijednošću indeksa 55 (od maksimalnih 100 poena) pa je Crna Gora ostvarila niži rezultat od prosjeka Evropske unije gdje je vrijednost indeksa 67,4. Vrijednost indeksa ukazuje da je najveća nejednakost muškaraca i žena u Crnoj Gori u domenu moći, a slijede domeni koji se odnose na vrijeme, znanje, novac i rad. Duboko ukorijenjene nejednakosti mogu se uočiti u sektoru obrazovanja, gdje većinu zaposlenih čine žene (76,6%), ali većina menadžera su muškarci (63%). Zaposlene žene se suočavaju sa nizom diskriminatornih praksi na radnom mjestu, dok majčinstvo i dalje predstavlja jednu od najčešćih prepreka napredovanju u karijeri ili zapošljavanju uopšte. Žene su često gurnute u slabo plaćene sektore i zanimanja uprkos sve većem stepenu obrazovanja, o čemu svjedoči razlika u platama (žene primaju 14% do 16% manje plate od muškaraca za isti angažman). One posjeduju samo 4% nekretnina, što povećava njihovu finansijsku nesigurnost i zavisnost. Evidentno je postojanje društveno tolerisanog porodičnog nasilja, rodno zasnovanog nasilja i čestih slučajeva femicida na koje još uvijek nema adekvatne reakcije nadležnih organa. Svakodnevno je vidljiva neproporcionalna predstavljenost na mjestima na kojima se donose političke odluke, stereotipno i uvredljivo predstavljanje i diskriminatorno omalovažavanje žena u medijima, javnom, političkom obraćanju kroz različite seksističke i mizogine forme ponašanja. Takođe, postoji snažno prisustvo institucionalnog nepoštovanja jednakosti u ekonomskim i društvenim odnosima i znatno veća stopa nezaposlenosti žena, diskriminacije žena prilikom zapošljavanja i napredovanja na poslu, te efekat “staklenog plafona” sa kojima se žene u crnogorskom društvu susrijeću. (Istraživanja: Indeks rodne ravnopravnosti, Žene i muškarci u Crnoj Gori, MICS).

Treba istaći da u Crnoj Gori pitanje rodne ravnopravnosti do nedavno nije bilo predmet značajnijeg interesovanja i proučavanja, te dugo nijesu postojali pouzdani statistički podaci i raspoloživa saznanja o istom i nije se mogao utvrditi njen stvarni obim, dinamika, struktura i druge značajne karakteristike. Iako rodna ravnopravnost dobija zavrijeđenu društvenu pažnju zahvaljujući snažnom djelovanju ženskih lobija, nevladinog sektora i međunarodnih organizacija, ni danas ne postoji dobar naučni doprinos ovoj oblasti, osobito sa pravnog aspekta. Utvrđeni indeks rodne ravnopravnosti i sprovedena istraživanja daju podatke o stvarnom, odnosno društvenom položaju žena u Crnoj Gori, ali njihov pravni položaj kroz koji se ostvaraju ženska prava ostaje nedovoljno obrađen u pravnoj nauci, te uticaj i važnost legislative i sudske prakse na sveukupan položaj žena često ostane zanemaren ili potcijenjen, pa se često o rodnoj ravnopravnosti govori sa drugih aspekata, ali ne i sa aspekta prava što ono i jeste.

Načelo rodne ravnopravnosti i nediskriminacije je jedno od temeljnih načela ljudskih prava sadržano u brojnim međunarodnim dokumentima i standardima. Iako Ustav, nacionalno zakonodavstvo i unutrašnja regulativa garantuju ženama socijalna, ekonomska i politička prava, napredak ka rodnoj ravnopravnosti očigledno ide sporim korakom. U tom smislu, postavlja se neizbježno pitanje: da li je postojeći pravni okvir adekvatan za postizanje standarda rodne ravnopravnosti i šta je u tom smislu potrebno uraditi za ostvarivanje ovog ljudskog prava u legislativi i sudskoj praksi?

Imajući u vidu navedeno, ova disertacija ima za cilj da na sveobuhvatan način evaluiira nivo usklađenosti crnogorskog pravnog sistema sa relevantnim međunarodnim okvirom i stepen napretka u ovoj oblasti u poređenju sa uporednim pravnim sistemima. Predmetna analiza predstavljaće osnovu za kreatore javnih politika i legislative i polaznu bazu za detektovanje problema u crnogorskoj legislativi u cilju davanja adekvatnih rješenja za unapređenje nacionalnog pravnog okvira iz ove oblasti. Disertacija ima za cilj da identifikuje međunarodne sudske standarde iz oblasti rodne ravnopravnosti što će doprinijeti njihovoj neposrednoj primjeni u praksi crnogorskih sudova - kao jednom od najvažnijih ustavnih postulata, te da analizira praksu sudova iz ove oblasti i iz toga izvuče značajne postulate i smjernice za davanje odgovora na gore postavljeno pitanje.

Pregled istraživanja

Kršenje ženskih ljudskih prava je od vjekova bilo uglavnom ignorisano ili shvaćeno kao prirodni dio statusa quo. Činjenica da političkim subjektima i na nacionalnom i na međunarodnom nivou dominiraju muškarci, "znači da se pitanja koja tradicionalno brinu muškarce smatraju opštom ljudskom brigom; dok se, "briga žena", za razliku od njih, smatra posebnom i ograničenom kategorijom" (Charlesworth, 1995:59). Mnogi autori su međunarodnom pravu pripisali duboko zasnovan rodni diskurs koji privileguje muškarce, pa tako prema Charlesworth H., ono pripada "muškom svijetu prava, maskirajući se u ljudsko" (Charlesworth, 1994:67) jer u potpunosti ignoriše koncepte roda. Borba žena za jednak tretman nije objeručke dočekana, niti je bila opšteprihvaćena, tako i danas još uvijek nailazi na zidove otpora širom svijeta. Začeci borbe vezuju se za feminizam koji se pojavio kao "pokret i kao tijelo ideja koje su imale za cilj da poboljšaju status žena i moć. To je dovelo u pitanje odnose moći između muškarca i žene koji su konvencionalno kategorisani kao prirodni" (Randall 2002:195).

Rodna diskriminacija i rodno zasnovano nasilje gotovo su se odomacili u svim sferama društva. To je postalo toliko prirodno da se, prema Kerr J., sveobuhvatna i sistemska kršenja ljudskih prava nad ženama smatraju dijelom „prirodnog poretka stvari“ (Kerr, 1993:3). Bunch C. smatra da je problem žena u tome što dominantna slika muškaraca kao političkih aktera na svjetskoj sceni onemogućava da problem rodne ravnopravnosti bude vidljiv (Bunch, 1995:12). Disertacija će analizirati promjenu androcentričnog diskursa međunarodnog prava i evoluciju ženskih prava koja danas zauzimaju značajno mjesto u međunarodnom sistemu zaštite ljudskih prava, te kako bez razumjevanja ovog sistema i njegove čvrste povezanosti sa domaćim pravnim sistemom nema ostvarivanja rodne ravnopravnosti na nacionalnom nivou.

Slom društava realnog socijalizma kakav je postojao u Crnoj Gori pratila je marginalizacija, poništavanje socijalnih i građanskih prava i represija žena iz javnog života, nauke i centara moći. U cijelom svijetu javni život je usmjeren na muškarce, rodno determinisan. Načini mišljenja su proizvod simboličke moći, tj. vladavina muškaraca. Iako su žene jedna od dvije komponente ljudske rase svakog društva, one se u svijetu i dalje tretiraju kao manjina, niža društvena klasa ili sloj (Filipović, 2002). Patrijarhalni i kulturni obrasci ponašanja ukorijenjeni u balkanskim zemljama, ratovi, ekonomski problemi, postojanje suprotstavljenog nacionalizma i nacionalističkih ideologija, uticali su da neki fundamentalni postulati emancipacije žena budu zaboravljeni i potisnuti sa javne scene. Sa naučnog stanovišta ističe se nedovoljna zastupljenost ove teme u naučnoj oblasti društvenih nauka, sa posebnim akcentom na pravne nauke koje kao takve na prvom mjestu trebaju da se bave pitanjima ženskih prava.

Patrijarhalni i kulturni obrasci ponašanja ukorijenjeni na našim prostorima direktno izražavaju autoritet muškaraca nad ženama. Ovi kulturni obrasci potkrepljuju se učenjem tradicionalnih polnih uloga još u ranom djetinjstvu, pa se diskriminacija žena "nasljedno" prenosi i na mlađe naraštaje. Saltzman A. u svojoj studiji piše o idealnoj crnogorki koja je morala biti poslušna i pokorna, a što je više pokoravala svoju ličnost, to je više rastao njen ugled u selu. Crnogorke se nisu bunile protiv svog položaja, već su ga svojim ponašanjem i ranim odgojem djece za te uloge učvrstile, pa su crnogorke muškarcima dale posebnu vrijednost (Saltzman, 1969:58). Osnovna misija crnogorki bila je da rađaju sinove koji će biti stub porodice, sinove koji će nastaviti mušku lozu. Dakle, udatim crnogorkama najgore što je moglo da se desi je da ne rode sina (Milić, 2015:36). Prema zapisima Milić Z. Crna Gora nije bila zemlja za žensku djecu, već samo za mušku (Milić, 2015). Dvostruki standardi duboko utkani u patrijarhalnoj kulturi omogućavali su muževima da nevjernu ženu čak i ubiju, a ako je muž zadrži mogao je da je tuče svakog dana, i ona tu ništa nije mogla, osim da trpi bez riječi (Milić, 2015:196).

Muškarci su vladali, a žene su služile i slušale jer je muževljeva riječ bila zakon, bez obzira kako se on ponašao prema njoj: "on okom, ona skokom" (Vujačić, 1980:62). Stereotipi o rodnim ulogama, siromaštvo, ekonomska i socijalna kriza i patrijarhalno nasljeđe, stvorili su pogodnu klimu za postojanje disfunkcionalnog društva u kojem se jedna čitava kategorija ljudi diskriminiše po kriterijumu rođenja, a koje se zadržalo i do danas (Radulović, Ljaljević, 2009).

U crnogorskoj pravnoj istoriji, od Nomokanona do danas, jasno su vidljivi obrisi patrijarhalne kulture i naslijeđa, dok su prvi ustavi žene pominjali samo sporadično i u žurbi. Vukčević M., analizira osnovne karakteristike rodne ravnopravnosti u crnogorskim ustavima sve od prvog pisanog akta Stege (1796), Petrovog zakonika i Danilovog zakonika do važećeg Ustava Crne Gore (2007). Prikazom materije iz rada Vukčević M. vide se jasni obrisi patrijarhalnog naslijeđa koji, prema njegovim riječima "i u najboljoj namjeri vrednovanja posežu za matricom u čijoj su osnovi biološke razlike, pa i priznanje ženske izuzetnosti ide samo do niova muške prosječnosti" (Vukčević, 2010:373). Dakle, dvostruki standardi u društvu preslikani su i na pravno uređenje države, gdje su žene za iste zločine snosile mnogo teže posljedice i kazne kroz vjekove.

Vremenom su kako u svijetu, tako i kod nas napravljeni određeni pomaci u ovoj oblasti. Na području međunarodnog prava ostvaren je značajan zaokret od androcentričnosti ka humanocentričnosti čemu su posebno doprinijeli međunarodni standardi iz predmetne oblasti donijeti pod okrljem Ujedinjenih nacija, Savjeta Evrope i Evropske unije koji će svoje mjesto naći u ovoj disertaciji. Stoga, ova disertacija ima za cilj da evaluiira koliko je daleko Crna Gora odmakla od oštre rodne polarizacije prikazane u pregledu istraživanja do danas, kroz analizu međunarodnog sistema zaštite ženskih prava i praksu međunarodnih sudova, kao i analizu crnogorskog pravnog okvira i jurisprudencije nacionalnih sudova iz predmetne oblasti.

Cilj i hipoteze

U crnogorskom društvu, ali i u svijetu, rodna ravnopravnost još uvijek nije ostvarena iako je ona i kao princip i kao pravo apsolutno neupitno i kao takvo utemeljeno u najvišim pravnim aktima na međunarodnom i nacionalnom nivou. Iako su preduzeti izvjesni koraci ka ispravljanju nejednakih i nepravednih uslova, generalno govoreći, žene u Crnoj Gori još uvijek imaju manje mogućnosti, niži status i manje moći i uticaja od muškaraca. U istorijskoj retrospektivi, postavlja se pitanje *stvarnog napretka pravnog okvira i sudske prakse ka dostizanju standarda rodne ravnopravnosti na koje ova disertacija ima za cilj da odgovori.*

Sa tim u vezi, disertacija u svom temelju ima brojne **ciljeve**:

- prikazivanje ideje rodne ravnopravnosti kao jednog od osnovnih ljudskih prava;
- ukazivanje na probleme diskriminacije i marginalizacije žena u javnoj i privatnoj sferi života;
- sagledavanje domaćih i međunarodnih standarda rodne ravnopravnosti, kao i društvenog i pravnog položaja žene u svijetu i kod nas;
- izvršiti sistemsku analizu stanja u oblasti rodne ravnopravnosti, pravne regulative, standarda ženskih prava i jurisprudencije međunarodnih i domaćih sudova;
- ukazivanje na postojeći pravni okvir i sudsku praksu, njihove pozitivne i negativne strane;
- i sublimiranje i pružanje naučnih smjenica i doprinosa ka zaokruživanju odgovarajućeg pravnog okvira i sudske prakse iz predmetne oblasti.

Sa tim u vezi, **hipoteza disertacije** glasi:

Crna Gora je djelimično harmonizovala svoj pravni okvir sa relevantnim međunarodnim okvirom, pa postojeći pravni okvir ne omogućava sveobuhvatno ostvarivanje standarda rodne ravnopravnosti.

Propratne hipoteze su:

Međunarodni i domaći zakoni moraju da budu čvrsto povezani kako bi se standard rodne ravnopravnosti u potpunosti postigao na nacionalnom nivou.

Sudska praksa je od krucijalne važnosti za postizanje standarda rodne ravnopravnosti jer pravni okvir sam po sebi nije dovoljan bez adekvatnog sprovođenja zakona.

Crnogorski sudovi u svojoj praksi ne primjenjuju međunarodne standarde rodne ravnopravnosti.

Standardi rodne ravnopravnosti iz jurisprudencije međunarodnih sudova nisu prepoznati u crnogorskoj legislativi i sudskoj praksi.

Rodna ravnopravnost u jurisprudenciji domaćih sudova je od velikog značaja za postizanje jednakog pristupa pravdi.

Dakle, u disertaciji će se razmatrati normativne pretpostavke i stvarne mogućnosti za postizanje standarda rodne ravnopravnosti. Kako bi se ispitala hipoteza izvršiće se analiza međunarodnog i nacionalnog okvira rodne ravnopravnosti, kao i evaluacija primjene međunarodnih dokumenata i standarda iz predmetne oblasti u Crnoj Gori, te bogata praksa međunarodnih sudova iz ove oblasti i primjena ovih standarda u crnogorskoj jurisprudenciji.

Materijali, metode i plan istraživanja

U cilju testiranja hipoteza, u disertaciji će biti korišćene uobičajene pravne metode koje se koriste u istraživačkom radu. U disertaciji će se koristiti normativno - dogmatički metod kao naučni metod saznanja pomoću kojeg će se obraditi lepeza relevantnih međunarodnih dokumenata i standarda iz predmetne oblasti i domaći pravni okvir kroz detaljnu analizu pozitivnih pravnih propisa kako u njihovoj cjelini, tako i u njihovim djelovima. Korišćenjem ovog metoda, uz korišćenje i sociološkog metoda biće uspostavljen teorijsko - metodološki pristup, kroz opisivanje teorija i osnovnih pojmova koji su važni u okviru istraživanja. Pomoću istorijskog metoda biće dat osvrt na predmetnu problematiku kako sa međunarodnog tako i sa domaćeg aspekta posebno u svijetlu prikaza difuzije i istorijskog razvoja ravnopravnosti polova. U disertaciji će se koristiti i komparativni metod na osnovu kojeg će se izvršiti uporedno - pravna analiza više pravnih sistema u pogledu predmetne oblasti. Koristiće se i metod deskripcije prilikom opisivanja i definisanja osnovnih pojmova i relevantnih pitanja za predmetnu oblast, kao i empirijski metod čime će se akcenat staviti na statističke podatke i tehnike, odnosno na relevantna istraživanja, ali i studije slučaja iz prakse međunarodnih sudova i prakse crnogorskih sudova.

Osim navedenih uobičajenih pravnih metoda u disertaciji će se koristiti i brojni pomoćni metodi kako u pogledu strukturisanja sadržine materije, tako i u pogledu izvođenja konačnih sudova, odnosno zaključaka, kao što neki specifični metodološki pravni instrumenti: jezička analiza pravnih normi, autonomna analiza pravnih normi, ciljna analiza pravnih normi, analiza prakse međunarodnih i domaćih sudova, analiza vodeće pravne doktrine u međunarodnom i domaćem pravu, kao i analiza statističkih podataka, itd. Korišćenje ovih metodoloških mehanizama ima za cilj sagledavanje međunarodnog i domaćeg pravnog okvira i sudske prakse, kao i relevantnih uporednih pravnih sistema, te zaključivanje koje bi se prednosti iz uporednih prava mogle integrisati u crnogorsko zakonodavstvo i sudsku praksu i da li je ono u potpunosti harmonizovano sa međunarodnim pravom koje po Ustavu Crne Gore uživa primat nad domaćim. Ovi metodi pružiće objektivni prikaz trenutnog stanja u obrađivanim pravnim sistemima po pitanju predmetne tematike.

Izvori na kojima će se oslanjati izrada disertacije, analiza i istraživanje predmetne tematike su prvenstveno relevantni međunarodni dokumenti i standardi iz ove oblasti, Ustav Crne Gore i zakonski akti koji se bave ovom problematikom kako bi se dao potpun uvid u sve izvore koji su operacionalizovani i koji bliže propisuju stvarni obim i sadržaj instituta ravnopravnosti polova. Disertacija će se oslanjati i na radovima domaćih i inostranih autora i teoretičara koji se bave relevantnim pitanjima za predmetnu problematiku, kao i na analizama, izvještajima i drugim dostupnim radovima značajnim za zaokruživanje teme disertacije, i posljednje ali ne i manje važno na bogatu praksu međunarodnih sudova i praksu domaćih sudova iz ove oblasti.

Radi što boljeg sagledavanja i razumjevanja predmetnog istraživanja, disertacija će biti podijeljena na nekoliko cjelina, pri čemu će svaka od cjelina imati svoje značajne podcjeline. Osim uvoda, u kojem će se objasniti metodološki pristup, društvena i pravna priroda problematike, kao i hipoteze naučnog istraživanja, disertacija će biti sačinjena od nekoliko poglavlja i zaključnih ocjena.

U disertaciji će se dati teorijski osvrt na predmetnu problematiku kroz teorijsko - metodološki pristup i opisivanje teorija i osnovnih pojmova koji su važni u okviru istraživanja. Osnovni pojmovi biće izloženi jezgrovito, jer su oni u znatnoj mjeri analizirani u radovima naših i stranih teoretičara u ranijem periodu. Na opisnom nivou u radu, analiza će biti usmjerena na deskripciju i određivanje osnovnih teorijskih pojmova kao baze za bolje razumjevanje cjelokupnog rada, kao što su- feminizam, feministička teorija, pol i rod, ravnopravnost između polova, rodna diskriminacija i slično. Takođe, kroz istorijsko - pravni osvrt prikazaće se razvoj ženskih prava u svijetu i kod nas. U okviru ovog dijela ukazaće se na činjenice koje su važne za istoriju feminizma i na društvene i pravne promjene koje su uticale na položaj žena. Posebna pažnja biće posvećena međunarodno - pravnom okviru i međunarodnim standardima utvrđenim i donijetim na tri nivoa: nivo Ujedinjenih nacija, nivo Savjeta Evrope i nivo Evropske unije. Disertacija će kroz komparativni okvir izvršiti uporedno - pravni prikaz najznačajnijih karakteristika različitih pravnih sistema kada su u pitanju ženska prava. Cilj ovog dijela disertacije jeste da se pruži bolji pregled i razumjevanje ove teme tako što će se prikazati različita ustavna i zakonska rješenja i izvršiti komparacija sa domaćim sistemom. Zatim, kroz pozitivno - pravni okvir disertacije prikazaće se i analizirati ustavno - pravni i zakonodavno - pravni okvir rodne ravnopravnosti u Crnoj Gori, a kroz poseban dio disertacije prikazaće se i bogata praksa međunarodnih sudova iz oblasti rodne ravnopravnosti, sa posebnim osvrtom na sledeća prava: rodna diskriminacija i nejednakost, seksualno nasilje, prundna golotinja, prinudni ginekološki pregled, nasilje u porodici, ropstvo, prinudni rad, trgovina ljudima i reproduktivna prava. U ovom dijelu izvršiće se identifikacija međunarodnih sudskih standarda iz ove oblasti, nakon čega će biće prikazana i praksa crnogorskih sudova i izvršena analiza primjene identifikovanih međunarodnih sudskih standarda u crnogorskoj sudskoj praksi. U disertaciji će se osim pregleda domaće legislative i sudske prakse dati i prikaz istraživanja iz ove oblasti i istraživanja autora disertacije. Na osnovu empirijskog dijela rada, utvrdiće se, između ostalog, da li i u kojoj mjeri postojeći pravni okvir ima uticaja na postizanje rodne ravnopravnosti u cjelokupnom društvenom sistemu, te od kolikog je značaja sudska praksa za ostvarivanje i sprovođenja zakona koji se tiču ženskih prava. Najzad, posljednja cjelina rada posvećena je zaključnim ocjenama u kojima će se na bazi analize prethodnih djelova rada izvršiti sublimacija i sinteza rada. Njima će biti sublimirana cjelina materije, ali ne na nivou deskripcije, već kroz iznošenje konkretnih prijedloga za unaprjeđenje i poboljšanje nacionalnog pravnog okvira iz oblasti rodne ravnopravnosti.

Poglavlja u disertaciji će biti logično i koherentno sistematizovana, u svemu saglasna sa metodološkim zahtjevima izrade naučno - istraživačkog rada. Dobijeni rezultati biće originalni i zasnovani ne samo na bibliografskim referencama, već će biti i naučno fokusirani kroz kvalitativno - kvantitativne sadržajne elemente, analizu legislativnog okvira i sudske prakse iz oblasti rodne ravnopravnosti, uz autentičnu interpretaciju dobijenih podataka od strane autora disertacije, čime će se doprinijeti naučnom pozicioniranju predmetne tematike.

Očekivani naučni doprinos

Više je razloga obrađivanja ove tematike, a jedan od glavnih jeste njen naučni doprinos. Aktuelnost teme, ratovi na prostoru Balkana, veliki ekonomski problemi i siromaštvo, postojanje nacionalizma i nacionalističkih ideologija koje su dovele do zaborava nekih od temeljnih postupalata ostvarene emancipacije žena, pokretač su izrade ove disertacije. Sa naučnog aspekta, nedovoljno prisustvo predmetne tematike na polju društvenih, a posebno pravnih nauka predstavlja samo po sebi određeni doprinos nauci. U crnogorskoj pravnoj teoriji ovo pitanje nije dovoljno istraženo, a donedavno ova tematika nije privlačila posebnu pažnju. Aktuelni Ustav Crne Gore po prvi put u ustavnom razvitku eksplicitno garantuje ravnopravnost žene i muškaraca među svojim osnovnim načelima gdje obavezuje državu da vodi politiku jednakih mogućnosti.

Na prostoru Crne Gore ima neznatan broj radova koji se dijelom svoje materije odnose na predstavljenu temu, ili se odnose samo na njene pojedine aspekte, ali rijetko i na pravni aspekt, sa posebnim osvrtom na međunarodni. Imajući u vidu navedeno, rad će dati svoj doprinos u ovoj oblasti jer će na sveobuhvatan način da evaluiira i analizira da li crnogorski pravni okvir omogućava postizanje rodne ravnopravnosti, posebno u svijetlu primjene postojećih međunarodnih standarda donijetih pod okriljem međunarodnih organizacija, kao i međunarodnih sudskih standarda u crnogorskoj legislativi i sudskoj praksi.

Dakle, ravnopravnost žena i muškaraca nije samo cilj sam po sebi, ona je preduslov za ostvarivanje ljudskih prava i ljudski razvoj uopšte, zbog čega bi ovo pitanje trebalo posebno obraditi sa pravnog aspekta. Promovisanje rodne ravnopravnosti i osnaživanje žena treba da bude centralna tema svakog crnogorskog zakonodavstva kako bi se imao bolji pristup razvoju. Napor ove disertacije uključuje zalaganje za jednaka prava žena i djevojčica, borbu protiv diskriminatornih praksi i osporavanje uloga i stereotipa koji utiču na nejednakosti i isključenost kroz analizu postojećeg pravnog okvira i detektovanje propusta i prostora za poboljšanjem, odnosno, utemeljenjem adekvatnog pravnog okvira i sudske prakse koji će u budućnosti zaista moći omogućiti postizanje standardna rodne ravnopravnosti *u cjelosti*.

Uprkos činjenici da je rodna ravnopravnost Ustavom propisan princip, evidentno je da diskriminacija po osnovu roda još uvijek postoji, da su ovom diskriminacijom nesrazmjerno pogođene žene i da ovaj princip i pravo nije uvijek ostvaren u praksi. Ova disertacija će tvorcima legislative i kreatorima javnih politika ukazati na postojeće nedostatke u crnogorskom pravnom okviru u ovoj oblasti, kao i na moguća rješenja i prijedloge za stvaranje adekvatnijeg pravnog okvira za postizanje standarda rodne ravnopravnosti u potpunosti. Osim toga, disertacija će crnogorskim sudovima predstavljati bazu konkretno identifikovanih međunarodnih sudskih standarda o rodnoj ravnopravnosti, što će doprinijeti njihovoj neposrednoj primjeni kao jednog od najvažnijih ustavnih postulata. Takođe, vrijedi napomenuti da u Crnoj Gori problem nije samo u nedostatku zakonskih akata, već i u njihovom ignorisanju, sve to zbog gore navedenih poremećenih odnosa, vrijednosti i ponašanja, kao i nepoznavanja suštine ovog instituta i njegovog značaja. Stoga je širenje svijesti i znanja o rodnoj ravnopravnosti kao osnovnom ljudskom – *pravu* - veoma važan segment djelovanja, a osim ukazivanja na postojeće propuste u crnogorskoj legislativi i sudskoj praksi, jedan od osnovnih ciljeva i zadataka ove disertacije.



Explanation of the topic

Title of the dissertation **“Gender Equality and Jurisprudence: *Using International Gender Standards to promote Women’s Rights in Montenegrin legislature and Case - Law*”** refers to the analysis of gender equality from the aspect of two reference legal frameworks - international and domestic, as well as to the evaluation of the implementation of relevant international standards in the Montenegrin legal system, with special reference to the jurisprudence of international and national courts.

In a patriarchal culture such as Montenegro, there are prejudices and misconceptions about the status of women not only in society but also in private life. Women in Montenegro are still unequal and the problems for achieving gender equality have yet to be addressed in their various forms. The Gender Equality Index was first calculated in Montenegro in 2019 with an index value of 55 (out of a maximum of 100 points), so Montenegro achieved a lower result than the European Union average where the index value is 67.4. The value of the index indicates that the greatest inequality of men and women in Montenegro is in the domain of power, followed by the domains related to time, knowledge, money and work. Deep-rooted inequalities can be observed in the education sector, where the majority of employees are women (76.6%), but most managers are men (63%). Employed women face a range of discriminatory practices in the workplace, while motherhood remains one of the most common barriers to career advancement or employment in general. Women are often pushed into low-paid sectors and occupations despite increasing levels of education, as evidenced by the pay gap (women receive 14% to 16% less than men for the same engagement). They own only 4% of real estate, which increases their financial insecurity and dependence. The existence of socially tolerated domestic violence, gender-based violence and frequent cases of femicide is evident, to which there is still no adequate reaction from the competent authorities. Disproportionate representation in places where political decisions are made, stereotypical and offensive representation and discriminatory disparagement of women in the media are visible on a daily basis, public, political address through various sexist and misogynistic forms of behavior. There is also a strong presence of institutional disrespect for equality in economic and social relations and a significantly higher unemployment rate for women, discrimination against women in employment and promotion, and the "glass ceiling" effect that women face in Montenegrin society. (Research: Gender Equality Index, Women and Men in Montenegro, MICS).

It should be noted that the issue of gender equality in Montenegro has not been the subject of significant interest and study until recently, and for a very long time there were no reliable statistics and available knowledge and it was not possible to determine its actual scope, dynamics, structure and other important characteristics. Although gender equality has received well-deserved social attention thanks to the women's lobbies, the NGO sector and international organizations, there is still no good scientific contribution in this area, especially from a legal point of view. The determined gender equality index and the conducted research provide data on the real, ie social position of women in Montenegro, but their legal position through which women's rights are exercised remains insufficiently processed in legal science. Also, the influence and importance of legislative and judicial practice on the overall position of women often remains neglected or underestimated, so gender equality is usually discussed from other aspects, but not from the aspect of human rights which gender equality is in the first place.

The principle of gender equality and non-discrimination is one of the fundamental principles of human rights contained in numerous international documents and standards. Although the Constitution, national legislation and internal regulations guarantee women social, economic and political rights, progress towards gender equality is clearly slow. In this sense, the inevitable question arises: is the existing legal framework adequate to achieve gender equality standards and what has to be done in order to exercise this human right in legislation and case - law?

With this in mind, this dissertation aims to comprehensively evaluate the level of harmonization of the Montenegrin legal system with the relevant international framework and the degree of progress in this area compared to comparable legal systems. The subject analysis will be the basis for policy makers and legislators and a starting point for detecting problems in Montenegrin legislation in order to provide adequate solutions to improve the national legal framework in this area. The dissertation aims to identify international judicial standards in the field of gender equality that will contribute to their direct application in the practice of Montenegrin courts - as one of the most important constitutional postulates, and to analyze the practice of courts in this field in order to give an answer on the question above.

Research overview

Violations of women's human rights have always been largely ignored or understood as a natural part of the status quo. The fact that political actors, both nationally and internationally, are dominated by men, "means that issues that traditionally concern men are considered to be of general human concern; while, "women's care," in contrast, is considered a special and limited category" (Charlesworth, 1995: 59). Many authors have attributed to international law a deeply grounded gender discourse that privileges men, and so, according to Charlesworth H., it belongs to the "male world of law, disguised as human" (Charlesworth, 1994: 67) because it completely ignores gender concepts. The struggle of women for equal treatment was not welcomed, nor was it generally accepted, so even today it still encounters walls of resistance around the world. The beginnings of the struggle are linked to feminism, which emerged as a "movement and as a body of ideas aimed at improving women's status and power. This has called into question the power relations between men and women that are conventionally categorized as natural" (Randall 2002: 195).

Gender discrimination and gender-based violence have taken root in almost all spheres of society. This has become so natural that, according to Kerr J., comprehensive and systemic violations of human rights against women are considered part of the "natural order of things" (Kerr, 1993: 3). Bunch C. believes that the problem of women is that the dominant image of men as political actors on the world stage makes it impossible for the problem of gender equality to be visible (Bunch, 1995: 12). The dissertation will analyze the changing androcentric discourse of international law and the evolution of women's rights, which today occupy a significant place in the international human rights system, and how without understanding this system and its strong connection with the domestic legal system there is no possibility of achieving gender equality at the national level.

The collapse of the societies of real socialism as it existed in Montenegro was accompanied by marginalization, annulment of social and civil rights and repression of women from public life, science and centers of power. All over the world, public life is focused on men, gender-determined. Ways of thinking are a product of symbolic power, ie. the rule of men. Although women are one of the two components of the human race of every society, they are still treated in the world as a minority, lower social class or stratum (Filipović, 2002). Patriarchal and cultural patterns of behavior rooted in the Balkan countries, wars, economic problems, the existence of opposing nationalism and nationalist ideologies, have influenced some fundamental postulates of women's emancipation to be forgotten and suppressed from the public scene.

Patriarchal and cultural patterns of behavior rooted in our region directly express the authority of men over women. These cultural patterns are supported by learning traditional gender roles in early childhood, so discrimination against women is "hereditary" and passed on to younger generations. Saltzman A. in his study writes about the ideal Montenegrin woman who had to be obedient and submissive, and the more she subdued her personality, the more her reputation in the village grew. Montenegrin women did not protest against their position, but strengthened it for these roles with their behavior and early upbringing of children, so Montenegrin women gave special value to men (Saltzman, 1969: 58). The basic mission of Montenegrin women was to give birth to sons who will be the pillar of the family, sons who will continue the male line. So, the worst thing that could happen to married Montenegrins is that they do not have a son (Milić, 2015: 36). According to the records of Milić Z. Montenegro was not a country for female children, but only for male children (Milić, 2015). Double standards deeply ingrained in patriarchal culture allowed husbands to even kill an unfaithful wife, and if the husband kept her he could beat her every day, and she could do nothing but suffer without words (Milić, 2015: 196).

Men ruled, and women served and listened because the husband's word was the law, regardless of how he treated her: "he with the eye, she with the jump" (Vujačić, 1980: 62). Stereotypes about gender roles, poverty, economic and social crisis and patriarchal heritage have created a favorable climate for the existence of a dysfunctional society in which an entire category of people is discriminated against on the basis of birth, which has persisted to this day (Radulović, Ljaljević, 2009).

In Montenegrin legal history, from the Nomocanon to the present day, the outlines of patriarchal culture and heritage are clearly visible, while the first constitutions mentioned women only sporadically and in a hurry. Vukčević M., analyzes the basic characteristics of gender equality in Montenegrin constitutions, from the first written act of Stega (1796), Peter's Code and Danilo's Code to the current Constitution of Montenegro (2007). The presentation of the material from Vukčević M.'s work shows clear outlines of patriarchal heritage which, according to him, "even in the best intention of evaluation reach for the matrix based on biological differences, even the recognition of female excellence goes only to the level of male average" (Vukčević, 2010: 373). Thus, the double standards in society have been reflected in the legal system of the state, where women have suffered much more severe consequences and punishments for the same crimes over the centuries.

Over time, both in the world and in our country, certain progress has been made in this area. In the field of international law, there has been a significant shift from androcentrism to humanocentrism, which was especially contributed by international standards in the field adopted by the United Nations, the Council of Europe and the European Union, which will find their place in this dissertation. Therefore, this dissertation aims to evaluate how far Montenegro has moved away from the sharp gender polarization shown in the review of research to date, through an analysis of the international system of women's rights and international court practice, as well as an analysis of Montenegrin legal framework and jurisprudence in this area.

Aim and hypotheses

In Montenegrin society, but also in the world, gender equality has not yet been achieved, although it is, as a principle and as a law, absolutely unquestionable and as such established in the highest legal acts at the international and national level. Although some steps have been taken to correct unequal and unfair conditions, in general, women in Montenegro still have fewer opportunities, lower status and less power and influence than men. In historical retrospect, the question arises of the real progress of the legal framework and case law towards achieving the standard of gender equality to which this dissertation aims to respond.

In this regard, the dissertation is fundamentally numerous **goals**:

- presenting the idea of gender equality as one of the basic human rights;
- pointing out the problems of discrimination and marginalization of women in the public and private spheres of life;
- consideration of domestic and international standards of gender equality, as well as the social and legal position of women in the world and in our country;
- perform a systematic analysis of the situation in the field of gender equality, legal regulations, women's rights standards and jurisprudence of international and domestic courts;
- pointing out the existing legal framework and case law, their positive and negative sides;
- and sublimating and providing scientific guidance and input to complete the relevant legal framework and case law in the field.

In this regard, the **dissertation hypothesis** is:

Montenegro has partially harmonized its legal framework with the relevant international framework, so the existing legal framework does not allow gender equality standards to be fully achieved.

Accompanying hypotheses are:

International and domestic laws must be firmly linked in order to fully achieve gender equality at the national level.

Judicial practice is crucial for achieving gender equality because the legal framework alone is not sufficient without adequate law enforcement.

Montenegrin courts do not apply international standards of gender equality in their practice.

Gender equality standards from the jurisprudence of international courts are not recognized in Montenegrin legislation and case - law.

Gender equality in the jurisprudence of domestic courts is of the great importance for achieving equal access to justice.

Thus, the dissertation will consider normative assumptions and real possibilities for achieving gender equality standards. In order to test the hypotheses, an analysis of the international and national framework of gender equality will be performed, as well as an evaluation of the application of international documents and standards in the subject area in Montenegro, and rich practice of international courts in this area and application of these standards in Montenegrin jurisprudence.

Materials, methods, and research plan

In order to test hypotheses, the dissertation will use the usual legal methods used in research work. The dissertation will use the normative - dogmatic method as a scientific method of knowledge which will deal with a range of relevant international documents and standards in the field and domestic legal framework through a detailed analysis of positive legal regulations in their entirety and in their parts. Using this method, along with the use of the sociological method, a theoretical - methodological approach will be established, through the description of theories and basic concepts that are important in the research. Using the historical method, the subject matter will be reviewed from both the international and domestic aspects, especially in the light of the presentation of diffusion and the historical development of gender equality. The dissertation will also use a comparative method on the basis of which a comparative legal analysis of several legal systems in relation to the subject area will be performed. The method of description will be used when describing and defining basic concepts and relevant issues for the subject area, as well as the empirical method which will emphasize statistical data and techniques, ie relevant research, but also case studies from the practice of international courts and Montenegrin courts.

In addition to the above common legal methods, the dissertation will use a number of auxiliary methods both in terms of structuring the content of the matter and in terms of derived final judgments or conclusions, such as some specific methodological legal instruments: linguistic analysis of legal norms, autonomous analysis of legal norms, target analysis of legal norms, analysis of the practice of international and domestic courts, analysis of the leading legal doctrine in international and domestic law, as well as analysis of statistical data, etc. The use of these methodological mechanisms aims to review the international and domestic legal framework and case law, as well as relevant comparative legal systems, and to conclude which advantages of comparative law could be integrated into Montenegrin legislation and case law and whether it is fully harmonized with international law which, according to the Constitution of Montenegro, enjoys primacy over domestic law. These methods will provide an objective view of the current situation in the legal systems under consideration on the subject matter.

The sources on which the dissertation, analysis and research of the subject will be based are primarily relevant international documents and standards in this field, the Constitution of Montenegro and legal acts dealing with this issue in order to provide full insight into all sources that are operationalized and prescribe in more detail the actual scope and content of the institute of gender equality. The dissertation will rely on the work of domestic and foreign authors and theorists dealing with relevant issues, as well as on analyzes, reports and other available works important for rounding off the topic of the dissertation, and last but not least on the rich practice of international courts and the practice of domestic courts in this area.

In order to better understand and understand the subject research, the dissertation will be divided into several units, each of which will have its own significant subunits. In addition to the introduction, which will explain the methodological approach, social and legal nature of the issue, as well as hypotheses of scientific research, the dissertation will consist of several chapters and concluding remarks.

The dissertation will provide a theoretical overview of the subject through a theoretical - methodological approach and a description of theories and basic concepts that are important in research. The basic concepts will be presented concisely, because they have been significantly analyzed in the works of our and foreign theorists in the earlier period. At the descriptive level, the analysis will focus on describing and defining basic theoretical concepts as a basis for a better understanding of the whole work, such as feminism, feminist theory, gender, gender equality, gender discrimination and the like. Also, through the historical-legal review, the development of women's rights in the world and in our country will be presented. This section will point out the facts that are important for the history of feminism and the social and legal changes that have affected the position of women. Special attention will be paid to the international legal framework and international standards established and adopted at three levels: the level of the United Nations, the level of the Council of Europe and the level of the European Union. Through the comparative framework, the dissertation will make a comparative - legal presentation of the most important characteristics of different legal systems when it comes to women's rights. The aim of this part of the dissertation is to provide a better overview and understanding of this topic by presenting various constitutional and legal solutions and making a comparison with the domestic system. Then, through the positive - legal framework of the dissertation, the constitutional - legal and legislative - legal framework of gender equality in Montenegro will be presented and analyzed, and through a special part of the dissertation the rich practice of international courts in the field of gender equality will be presented. gender discrimination and inequality, sexual violence, prudent nudity, forced gynecological examination, domestic violence, slavery, forced labor, human trafficking and reproductive rights. In this part, the identification of international judicial standards in this area will be performed, after which the practice of Montenegrin courts will be presented and an analysis of the application of identified international judicial standards in Montenegrin judicial practice will be performed. In addition to a review of domestic legislation and case law, the dissertation will also present research in this area and research by the authors of the dissertation. Based on the empirical part of the paper, it will be determined, among other things, whether and to what extent the existing legal framework has an impact on achieving gender equality in the entire social system, and the importance of jurisprudence for exercising and enforcing women's rights. Finally, the last part of the paper is dedicated to the final assessments in which, based on the analysis of previous parts of the paper, sublimation and synthesis of the paper will be performed. They will sublimate the whole matter, but not at the level of description, but through the presentation of concrete proposals for the improvement and enhancement of the national legal framework in the field of gender equality.

The chapters in the dissertation will be logically and coherently systematized, in all respects in accordance with the methodological requirements of scientific - research work. The obtained results will be original and based not only on bibliographic references, but will also be scientifically focused through qualitative - quantitative content elements, analysis of the legislative framework and case law in the field of gender equality, with authentic interpretation of the data obtained by the dissertation author.

Expected scientific contribution

There are several reasons for dealing with this topic, and one of the main ones is its scientific contribution. The topicality of the topic, wars in the Balkans, great economic problems and poverty, the existence of nationalism and nationalist ideologies that have led to the oblivion of some of the fundamental steps in the emancipation of women, are the initiators of this dissertation. From the scientific aspect, the insufficient presence of the subject in the field of social, and especially legal sciences, represents in itself a certain contribution to the science. In Montenegrin legal theory, this issue has not been sufficiently researched, and until recently, this topic did not attract special attention. The current Constitution of Montenegro, for the first time in its constitutional development, explicitly guarantees the equality of women and men among its basic principles, where it obliges the state to pursue a policy of equal opportunities.

In Montenegro, there are a small number of papers that relate in part to the presented topic, or relate only to its individual aspects, but rarely to the legal aspect, with special reference to the international. With this in mind, the paper will contribute in this area as it will comprehensively evaluate and analyze whether the Montenegrin legal framework allows gender equality to be fully achieved, especially in the light of the application of existing international standards adopted under the auspices of international organizations, as well as international judicial standards and their implementation in the Montenegrin legislation and case - law.

Therefore, equality between women and men is not only an end in itself, it is a precondition for the realization of human rights and human development in general, which is why this issue should be specifically addressed from the legal aspect. Promoting gender equality and women's empowerment should be a central theme of any Montenegrin legislation. The effort of this dissertation includes advocating for equal rights for women and girls, combating discriminatory practices and challenging roles and stereotypes affecting inequalities and exclusion by analyzing the existing legal framework and detecting gaps and room for improvement, ie establishing an adequate legal framework and case - law which will in the future really be able to achieve gender equality standards as a whole.

Despite the fact that gender equality is a principle prescribed by the Constitution, it is evident that discrimination based on gender still exists, that women are disproportionately affected by this discrimination and that this principle and right is not always realized in practice. This dissertation will point out to the legislators and policy makers the existing shortcomings in the Montenegrin legal framework in this area, as well as possible solutions and proposals for creating a more adequate legal framework for achieving gender equality standards in full. In addition, the dissertation will provide Montenegrin courts with a base of specifically identified international judicial standards on gender equality, which will contribute to their direct application as one of the most important constitutional postulates. Also, it is worth noting that in Montenegro the problem is not only in the lack of legal acts, but also in ignoring them, all because of the above disturbed relations, values and behaviors, as well as ignorance of the essence of this institute and its importance. Therefore, spreading awareness and knowledge about gender equality as a basic human right - a very important segment of action, and in addition to pointing out existing shortcomings in Montenegrin legislation and case law, is one of the main goals and objectives of this dissertation.

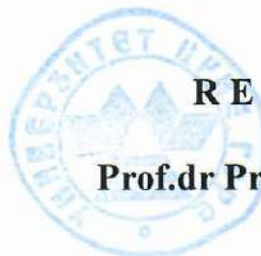
