BIOGRAFIJA

Prof. dr Nataša Duborija-Kovačević je rođena 1973. godine u Bijelom Polju. Osnovnu školu i gimnaziju, smjer Saradnik u prirodnim naukama, završila je u Podgorici. Diplomirala je na Medicinskom fakultetu Univerziteta u Beogradu 1999. godine kao jedan od najboljih studenata generacije (srednja ocena 9.63). Iste godine upisala je magistarske studije iz Kliničke farmakologije i terapije na Institutu za farmakologiju, kliničku farmakologiju i toksikologiju Medicinskog fakulteta u Beogradu kao prvorangirani kandidat na novoosnovanom studijskom programu. Magistrirala je 2003, a doktorsku disertaciju iz kliničke farmakologije odbranila 2008. godine na Medicinskom fakultetu Univerziteta u Novom Sadu.

Od 2000. godine je zaposlena na Medicinskom fakultetu Univerziteta Crne Gore, kao saradnik u nastavi na predmetu Farmakologija sa toksikologijom. U docenta je izabrana 2009, a u vanrednog profesora 2015. godine. U tom periodu je, u nedostatku kadra, izvodila teorijsku nastavu iz Farmakologije i Kliničke farmakologije na svim studijskim programima Medicinskog fakulteta na kojima se izučavaju ovi predmeti (Medicina, Stomatologija, Farmacija, Visoka medicinska škola). Odlukom Senata UCG u redovnog profesora izabrana je 2020. godine.

Bila je autor ili koautor nekoliko univerzitetskih udžbenika, poglavla u monografijama i stručnim knjigama, predavač na više desetina međunarodnih i domaćih naučnih i stručnih skupova, autor ili koautor velikog broja in extenso objavljenih naučnih radova, rukovodilac ili član istraživačkog tima u više međunarodnih i nacionalnih projekata, recenzent u nekoliko međunarodnih časopisa i sl.

Do navršene 40. godine bila je član Centra mladih naučnika CANU. Uspješno je sarađivala sa Agencijom za ljekove i medicinska sredstva, Ministarstvom zdravlja Crne Gore i Fondom za zdravstveno osiguranje u oblastima registracije ljekova, izrade tzv. Pozitivne liste ljekova, pravne regulative u oblasti ljekova i sl. Od 2017. godine je član Centra za unapređenje kvaliteta UCG, a u periodu 2021–2023. bila je potpredsjednik Savjeta za naučnoistraživačku djelatnost u Ministarstvu nauke.

Dobitnik je više međunarodnih i nacionalnih stipendija i priznanja.

Član je EACPT i Srpskog farmakološkog društva. Govori engleski jezik. Udata je i majka dvoje djece. Živi u Podgorici.
