Mojmir Mrak je autor, koautor i recezent mnogih članaka i knjiga objavljenih od strane međunarodnih izdavača i respektivnih međunarodnih časopisa. ## **III. KEY WORK EXPERIENCE**

- More than 30 years of experience in research and consultancy in international finance and EU economic integration issues.
  - In the first part of this period most of my research and consultancy activities were in the areas of (i) international capital flows and external debt management, (ii) country risk assessment, and (iii) infrastructure financing, PPP and project financing, for clients in the former SFR Yugoslavia and in the Republic of Slovenia (government authorities and business, especially banking community). In addition, I have been a consultant of several international organisations, including IBRD, EBRD, IFC, Inter-American Development Bank and OECD.
  - Over the last 20 years, my activities have focused on EU economic • integration issues, such EU as accession, EU budget and medium-term financial perspective, structural funds and real convergence, and macroeconomic governance. Within this context, research projects and consultancy activities have been done for EU institutions, especially for the European Commission and the European Parliament. The following three should be mentioned specifically: (i) member of the "Knowledge for Growth" high level expert group formed by Commissioner Janez Potočnik between 2005 and 2009), (ii) member of the consultancy group that, within the context of the EU budget review, prepared a study on the reform of the revenue side of the EU budget for the European Commission (between 2007 and 2008), and (iii) preparation of the study on the financial crisis and global financial governance for the European Parliament (2010). Finally, I have done numerous consultancy assignments for various other international institutions, such as the UNDP, as well as for a number of Governments (Albania, Bosnia and Herzegovina, Kosovo, Macedonia, Montenegro, Romania, Serbia, Slovenia, Turkey, Ukraine) and for several private sector consultancy firms from different EU member states (Belgium, Germany, Netherlands, United Kingdom).
- More than 20 years of teaching experience in the areas of international finance and EU economic integration. At the University of Ljubljana, I have been teaching courses on International Finance and Economic Policies of the EU both at under-graduate and graduate levels. In 2012, I obtained Jean Monnet Chair on economic policies of the EU. I have been regular visiting professor at the postgraduate and executive education programs of the Wirtschaftuniversitat in Vienna (Austria). Over the recent 10 years, I also had courses (i) at the MBA program at the University in Siena (Italy), (ii) at the BSB Dijon (France), and at the MBA program at the university in Podgorica (Montenegro).
- More than 20 years of experience in designing and implementing Slovenian Government's policy in areas of international finance and EU integration. In the period since independence of Slovenia, I have been directly involved in negotiations aimed at reaching separate agreements between Slovenia as a debtor and the three groups of its foreign creditors (multilateral financial institutions, the Paris Club and the London Club). Between 1992 and 1996, I was the chief external debt negotiator of the Republic of Slovenia. In addition, I was responsible for early credit arrangements of Slovenia with the EBRD and IBRD. Between

1997 and 2014, I was chief advisor of the Slovenian Government on financial aspects of the country's EU accession process. Within this framework, I was responsible for (i) negotiations about the financial package of Slovenia's accession to the EU (between 2000 and 2002), and (ii) for the analytical back-up of the negotiations for the 2007-2013 financial framework of the EU (between 2003 and 2005) as well as negotiations for the 2014-2020 financial framework (between 2011 and 2013). Currently, I am advising the Slovenian Government on the negotiations for the 2021-2027 financial framework of the EU, including the issues of the revised Eurozone economic governance. Over this 20 years long period, I had also served as a member of the Supervisory Boards of the Slovenian Export Corporation (Slovenia's ECA) and of the Nova Ljubljanska banka (the largest commercial bank in the country) as well as a member of the largest European commercial bank. Between 2005 and 2009, I was a member of the "Knowledge for Growth" high level expert group formed by Commissioner Janez Potočnik.

Mojmirja Mraka, univ. dipl. ekon., v višji naziv, sprejela sklep, da kandidat ne izpolnjuje v celoti vseh pogojev določenih v »Merilih« z dne 5. 11. 1996 za izvolitev v naziv redni profesor za področje mednarodne finance na Ekonomski fakulteti.
