RISE: Research & Innovation Staff Exchange

Intersektorska i internacionalna razmjena osoblja s ciljem transfera znanja u istraživanju

„osoblje“ u razmjeni --> period 1 – 12 mjeseci aktivnosti umrežavanja

„osoblje“ mora biti povezano s instituijom pošiljaocem namjane 1 mjesec prije prvog „secondment“-a, a potom reintegrисano (trajanje i mehanizam nisu precizirani)

Sve razmjene između evropskih institucija moraju biti „international“ & „intersectoral“

Razmjene institucija iz Evrope s tzv. Trećim zemljama su „international only“

Max. 540 person/months

Trajanje projekta max. 48 mjeseci

Istraživači u svim fazama razvoja karijere (ESR, ER) – može biti predmetom poziva nakon odobrenja projekta

Poziv treba da uvaži pravila mobilnosti kao u redovnim MSCA

Grant ne može biti dodjeljen istraživačkim timovima

Grant ne može biti dodjeljen osobi zaposlenoj u *hosting* organizaciji

Trajanje projekta 36-60 mjeseci, a angažovanje istraživača u FP je 12-36 mjeseci



Tips and hints!

Proučiti sva dokumenta, a posebno „Guide for Applicant“

Blagovremeno dobiti saglasnost institucija za učešće i dogovoriti učešće supervizora

Nastojte imati ne-akademski sektor u projektu, kao i pitanja etike i polne ravnopravnosti

Sa supervizorom razraditi koncept i sve detalje radnog plana

Koristite templejte samo s PP, poštujte tehničke zahtjeve popunjavanja aplikacije, fontove, broj stranica...

Umjesto teksta koristite tabele, dijagrame, slike i sl.

Pišite jasnim jezikom, izbjegavajte žargon, budite konzistentni u upotrebi jezika

Tips and hints! (2)

Pišite ili u 1.ili 3.licu jednine, ali budite konzistentni

Izbjegavajte kopiranje teksta i ponavljanje misli i fraza

Literaturu referencirajte u fusnotama, veličina 8 ili 9 pts.

Koristite alate za naglašavanje teksta (bold, italic, underline) ali ne pretjerujte

Objasnite i detaljno opište svaki očekivani uticaj (*Expected impact*) predviđen pozivom

Dokažite kvalitet istraživanja, kandidata i supervizora – radovi, patenti...

Opišite detaljno „State-of-art“ i kako vaše istraživanje daje naučni doprinos...

Indikatore uspješnosti i efektivnosti za diseminaciju, komunikaciju i „outreach“ postaviti što realnije, kvalitativno i kvantitativno (SMART)
