

- Provision of necessary services for researchers on the move
 - Offer negotiated at national level (insurance, housing, etc.)
 - Offer negotiated at local level (French courses, banking, housing, etc.)
- 2) Database of researchers in mobility

- Negotiated offers with guests residences


















Database

- Sharing with EURAXESS network
 - Login and password access
 - Everyone only sees researchers within their geographical perimeter (postal code)
 - Possibility to share data in case of mobility within the country
- GDPR compliance
 - Definition of purposes and processing operations
 - Raising awareness among EURAXESS network members (Dos and Don'ts)
 - Personal space for researchers










- Overview of the tool developed for researchers to directly negociate with a landlord of their choice



FAQ: How do I ask researchers to register?


A: You don't worry about giving personal data to a library or a sports club, do you? So just tell them that we need their data to support them.
