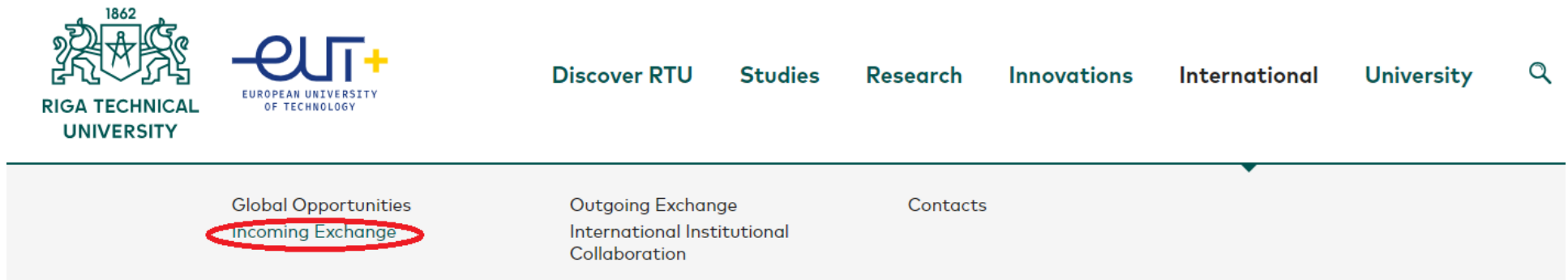

Annotation	This course helps to gain all needed skills and competencies for analysis and consolidation of a company data. After this course students will be able to use MS Excel and Power BI tools for analysis of business processes, develop data models for business and build visualizations on top of them. Will better understand the role of data and information in optimization and automation of internal and external business processes. Course paper is written on a topic proposed by a student, based on a guideline prepared by the teaching staff. Course paper is aimed to consolidate knowledge that was acquired in previous course "Business intelligence technologies I" and "Business intelligence technologies II".
Goals and objectives of the course in terms of competences and skills	The goal of the subject is to teach students to use MS Excel and Power BI tools for solving various data analysis challenges. After the course students are - raise awareness of the data sources of the enterprise; - develop capacity to consolidate multiple data sources; - develop capacity of algorithmising companies processes; - develop capacity to create a data model from available data sources - develop capacity to apply the capabilities provided by MS Excel and Power BI to visualize calculations - develop capacity to make proposals based on the results of the developed data model.
Structure and tasks of independent studies	During the course students will participate in 12 laboratory works that are divided in three blocks, after each block there is a test, parallel to class activities they write a course paper. For those who are not satisfied with semester results there is an option of taking exam.
