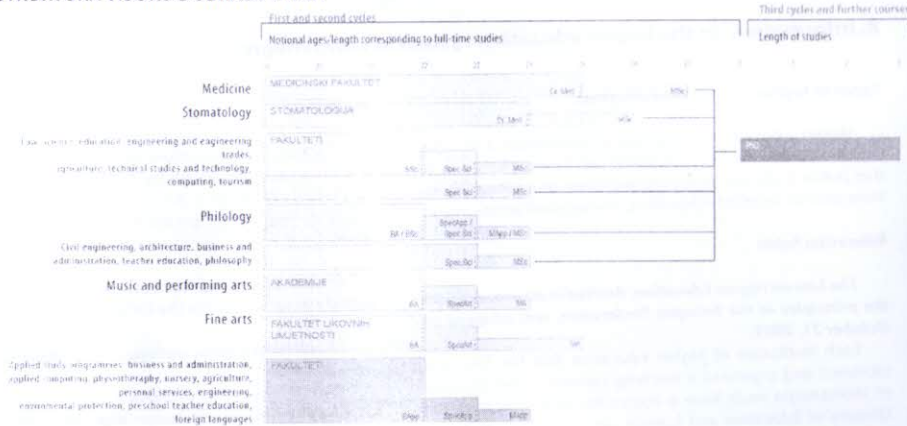

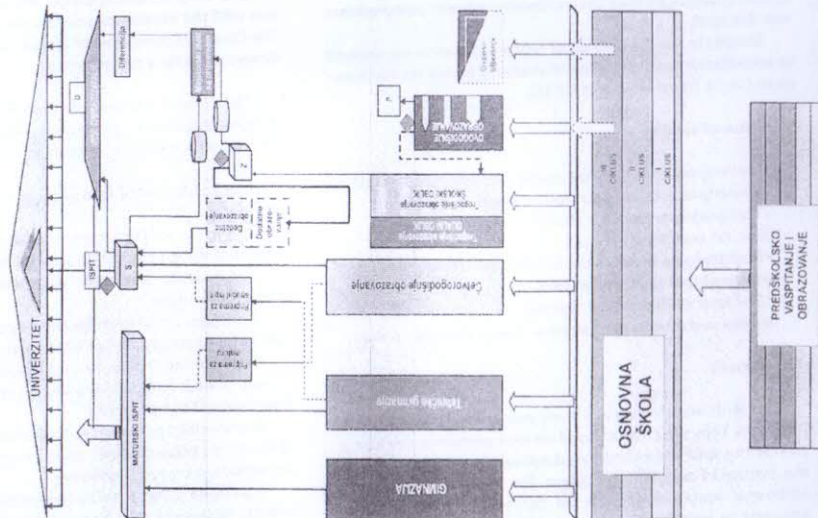

8. Information on the higher education system in Montenegro

Types of higher education institutions

Higher education is acquired at universities and other higher education institutions which can be established as either public or private. University and other educational institutions are independent in teaching, research and artistic work.

Education fields

The Law on Higher Education, drafted in accordance with the principles of the Bologna Declaration, was adopted on October 21, 2003.

Each institution of higher education that has been established and organises a teaching process in the Republic of Montenegro must have a licence for work issued by the Ministry of Education and Science. An institution can be issued a licence upon issuance of a certificate of accreditation of a study programme by the Council of Higher Education. The procedure of accreditation implies establishing validity of study programmes and their compliance with the valid standards of quality and the labour market, as well as conferring a certificate allowing the institution to award levels of education, qualifications and types of profession.

Educational process in the institutions of higher education is realised through academic and applied study programmes, as well as through different programmes of professional education and training. The structure of the higher education system is based on three cycles: undergraduate, postgraduate and doctoral.

Studies in the institutions of higher education are realised in accordance with the rules of studying based on the European Credit Transfer System (ECTS).

Duration of studies

- Undergraduate academic studies BSc, BA (3 or 4 years)
- Undergraduate applied studies, BApp (3years)
- Postgraduate specialist studies (BSc, BA and BApp +1 year)
- Postgraduate Master's studies (BSc, BA BApp + 2 years; postgraduate specialist studies +1)
- Doctoral studies (MSc + 3 years)
- Medical studies last longer: Dentistry - 5 years, Medicine - 6 years

Enrollment

Students are enrolled in a study programme on a competitive basis. They are ranked based on their performance during and at the end of secondary education, in accordance with the statute of a public institution. For specific programmes, additional requirements can be defined. Student status is acquired by enrollment in a study programme. Students and institutions conclude an agreement on studying defining their mutual rights and obligations. Foreign citizens may also enrol in a study programme.

Exams

Marking and assessment of students' knowledge is conducted in accordance with the ECTS grading scale: A, B, C, D, E and F. Pass grades are A, B, C, D and E. According to ECTS grading scale, they are interpreted as follows: A – excellent, B – very good, C – good, D – satisfactory, E – sufficient and F (fail).

Diplomas and degrees obtained after completing a study programme are the following:

- **Applied/academic undergraduate diploma**
– Bachelor's Degree
- **Specialist studies diploma** – Degree of Specialist
- **Applied/academic studies diploma** – Master's Degree
- **Diploma of academic title of a doctor of science/arts**
– Doctoral Degree

In compliance with the Bologna Declaration, a diploma supplement is issued in addition to the diploma for the purpose of giving a detailed insight into the level, nature, content, system and rules of studying and the results achieved during studies of the person to whom the diploma is issued.

The Council for Higher Education

The Government appoints the Council for Higher Education with the mission to promote the area of higher education. The Council is composed of eleven members appointed by the Government for a six-year term.

The Council analyses the current state and achievements in higher education, gives expert proposals to the Government and, in that respect, has special authority to:

1. prepare a proposal of development strategy in higher education;
2. prepare an opinion on regulations governing issuance, modifications and withdrawal of licences;
3. prepare an opinion on criteria for appointment in academic titles;
4. prepare an opinion for the procedure of defining norms for financing higher education;
5. determine criteria for assessment of study programmes in view of their compatibility with professional needs and international comparability;
6. undertake periodic controls of quality assessment of licensed institutions and issue a certificate on initial accreditation or reaccreditation;
7. perform other activities prescribed by this Law and the decision on the establishment of the Council.

The organisation and operation of the Council will be defined in greater detail by its rules of procedure.





8. Informacije o sistemu visokog obrazovanja u Crnoj Gori

Tipovi ustanova visokog obrazovanja

Visoko obrazovanje se stiče na univerzitetu i drugim ustanovama visokog obrazovanja koje mogu biti osnovane kao javne i privatne. Univerzitet i druge ustanove uživaju slobodu nastave, istraživanja i umjetničkog rada.

Obrazovna djelatnost

21. oktobra 2003. godine usvojen je Zakon o visokom obrazovanju, koji je urađen u skladu sa principima Bolonjske Deklaracije.

Svaka ustanova koja je osnovana ili izvodi nastavu u Republici Crnoj Gori mora imati licencu za rad, koju izdaje Ministarstvo prosvjete i nauke. Ustanovi se može izdati licenca nakon dobijanja sertifikata o akreditaciji studijskog programa od strane Savjeta. Postupak akreditacije podrazumijeva utvrđivanje validnosti studijskih programa, njihove primjerenosti važećim standardima kvaliteta i tržištu rada i sertifikat obezbjeđivanja prava ustanovi na dodjelu stepena obrazovanja, zanimanja i profesije.

Obrazovna djelatnost na ustanovama visokog obrazovanja ostvaruje se kroz akademske i primijenjene studijske programe, kao i kroz raznovrsne programe stručnog usavršavanja i osposobljavanja. Struktura visokoobrazovnog sistema bazirana je na tri ciklusa i to: dodiplomski (osnovne studije), postdiplomski i doktorski.

Studije na ustanovama visokog obrazovanja ostvaruju se u skladu sa pravilima studiranja zasnovanim na Evropskom sistemu transfera kredita (ECTS – European Credit Transfer System).

Trajanje studija

- Osnovne akademske studije (3 ili 4 godine)
- Osnovne primijenjene studije (3 godine)
- Postdiplomске specijalističke studije (3+1 godina)
- Postdiplomске magistarske studije (3+2 godine; 3+1+2; 4+1 godina)
- Doktorske studije (3 godine)

Studije medicinskih nauka traju duže. Studije stomatologije traju 5 godina, a studije medicine 6 godina.

Upis

Upis na studijski program vrši se na konkurentskoj osnovi, u skladu sa rezultatima postignutim na završetku i tokom srednjeg obrazovanja, nakon sprovedenog postupka rangiranja, a saglasno sa statutom javne ustanove. Za određene programe mogu se odrediti i dodatni uslovi. Status studenta stiče se upisom na studijski program. Studenti i ustanova zaključuju ugovor o studiranju, u kome se definišu međusobna prava i obaveze. Pravo upisa na studijski program imaju i strani državljani.

Ispiti

Ocjenjivanje i vrednovanje znanja studenata vrši se u skladu sa ECTS skalom ocjena: A, B, C, D, E i F. Prelazne ocjene su: A, B, C, D, E i prema ECTS imaju sljedeće značenje: A (odličan), B (vrlodobar), C (dobar), D (zadovoljavajući), E (dovoljan) i F (nedovoljan).

Diplome i stepeni koji se stiču nakon završetka studijskog programa su:

- diploma primijenjenih/ akademskih osnovnih studija – stepen Bachelor;
- diploma specijalističkih studija – stepen specijaliste;
- diploma primijenjenih/akademskih magistarskih studija – stepen magistra;
- diploma akademskog naziva doktora nauka – stepen doktora nauka

U skladu sa Bolonjskom Deklaracijom uz diplomu obavezno se izdaje i dopuna diplome (Supplement), radi detaljnijeg uvida u nivo, prirodu, sadržaj, sistem i pravila studiranja i postignute rezultate tokom studija lica kome je diploma izdata.

Savjet za visoko obrazovanje

Za unapređivanje oblasti visokog obrazovanja Vlada imenuje Savjet za visoko obrazovanje. Savjet ima 11 članova koje imenuje Vlada, na period od 6 godina. *Savjet za visoko obrazovanje je nacionalno akreditaciono tijelo.*

Savjet analizira stanje i dostignuća u visokom obrazovanju, daje stručne predloge Vladi i, u tom cilju, ima posebna ovlaštenja da:

- 1) priprema predlog strategije razvoja visokog obrazovanja;
- 2) daje mišljenje u postupku utvrđivanja normativa za izdavanje, izmjene i oduzimanje licence;
- 3) daje mišljenje na mjerila za izbor u akademska zvanja;
- 4) daje mišljenje u postupku utvrđivanja normativa za finansiranje visokog obrazovanja;
- 5) utvrđuje mjerila za ocjenjivanje studijskih programa sa stanovišta njihove usklađenosti sa profesionalnim potrebama i međunarodne uporedivosti;
- 6) preduzima periodične kontrole kvaliteta licenciranih ustanova i izdaje sertifikat o po-četnoj akreditaciji, akreditaciji ili reakreditaciji;
- 7) vrši i druge poslove propisane ovim zakonom i aktom o osnivanju Savjeta.

Organizacija i način rada Savjeta bliže se uređuje poslovnikom o radu.

8. Information on the higher education system in Montenegro

Types of higher education institutions

Higher education is acquired at universities and other higher education institutions which can be established as either public or private. University and other educational institutions are independent in teaching, research and artistic work.

Education fields

The Law on Higher Education, drafted in accordance with the principles of the Bologna Declaration, was adopted on October 21, 2003.

Each institution of higher education that has been established and organises a teaching process in the Republic of Montenegro must have a licence for work issued by the Ministry of Education and Science. An institution can be issued a licence upon issuance of a certificate of accreditation of a study programme by the Council of Higher Education. The procedure of accreditation implies establishing validity of study programmes and their compliance with the valid standards of quality and the labour market, as well as conferring a certificate allowing the institution to award levels of education, qualifications and types of profession.

Educational process in the institutions of higher education is realised through academic and applied study programmes, as well as through different programmes of professional education and training. The structure of the higher education system is based on three cycles: undergraduate, postgraduate and doctoral.

Studies in the institutions of higher education are realised in accordance with the rules of studying based on the European Credit Transfer System (ECTS).

Duration of studies

- Undergraduate academic studies BSc, BA (3 or 4 years)
- Undergraduate applied studies, BApp (3years)
- Postgraduate specialist studies (BSc, BA and BApp +1 year)
- Postgraduate Master's studies (BSc, BA BApp + 2 years; postgraduate specialist studies +1)
- Doctoral studies (MSc + 3 years)
- Medical studies last longer: Dentistry - 5 years, Medicine – 6 years

Enrollment

Students are enrolled in a study programme on a competitive basis. They are ranked based on their performance during and at the end of secondary education, in accordance with the statute of a public institution. For specific programmes, additional requirements can be defined. Student status is acquired by enrollment in a study programme. Students and institutions conclude an agreement on studying defining their mutual rights and obligations. Foreign citizens may also enrol in a study programme.

Exams

Marking and assessment of students' knowledge is conducted in accordance with the ECTS grading scale: A, B, C, D, E and F. Pass grades are A, B, C, D and E. According to ECTS grading scale, they are interpreted as follows: A – excellent, B – very good, C – good, D – satisfactory, E – sufficient and F (fail).

Diplomas and degrees obtained after completing a study programme are the following:

- **Applied/academic undergraduate diploma**
– Bachelor's Degree
- **Specialist studies diploma** – Degree of Specialist
- **Applied/academic studies diploma** – Master's Degree
- **Diploma of academic title of a doctor of science/arts**
– Doctoral Degree

In compliance with the Bologna Declaration, a diploma supplement is issued in addition to the diploma for the purpose of giving a detailed insight into the level, nature, content, system and rules of studying and the results achieved during studies of the person to whom the diploma is issued.

The Council for Higher Education

The Government appoints the Council for Higher Education with the mission to promote the area of higher education. The Council is composed of eleven members appointed by the Government for a six-year term.

The Council analyses the current state and achievements in higher education, gives expert proposals to the Government and, in that respect, has special authority to:

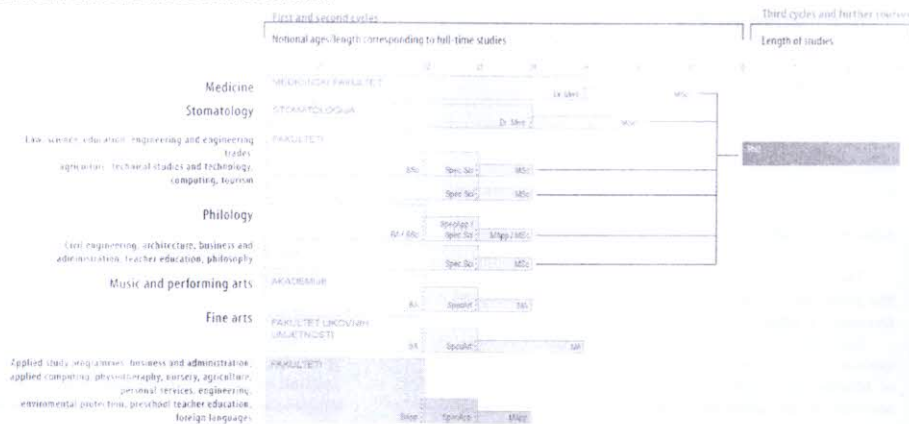
1. prepare a proposal of development strategy in higher education;
2. prepare an opinion on regulations governing issuance, modifications and withdrawal of licences;
3. prepare an opinion on criteria for appointment in academic titles;
4. prepare an opinion for the procedure of defining norms for financing higher education;
5. determine criteria for assessment of study programmes in view of their compatibility with professional needs and international comparability;
6. undertake periodic controls of quality assessment of licensed institutions and issue a certificate on initial accreditation or reaccreditation;
7. perform other activities prescribed by this Law and the decision on the establishment of the Council.

The organisation and operation of the Council will be defined in greater detail by its rules of procedure.



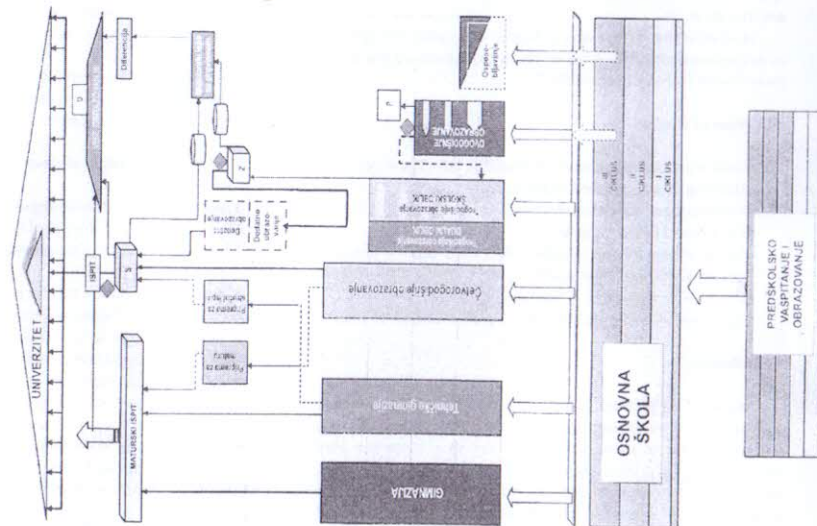

8. Informacije o sistemu visokog obrazovanja u Crnoj Gori

Tipovi ustanova visokog obrazovanja

Visoko obrazovanje se stiče na univerzitetu i drugim ustanovama visokog obrazovanja koje mogu biti osnovane kao javne i privatne. Univerzitet i druge ustanove uživaju slobodu nastave, istraživanja i umjetničkog rada.

Obrazovna djelatnost

21. oktobra 2003. godine usvojen je Zakon o visokom obrazovanju, koji je urađen u skladu sa principima Bolonske Deklaracije.

Svaka ustanova koja je osnovana ili izvodi nastavu u Republici Crnoj Gori mora imati licencu za rad, koju izdaje Ministarstvo prosvjete i nauke. Ustanovi se može izdati licenca nakon dobijanja sertifikata o akreditaciji studijskog programa od strane Savjeta. Postupak akreditacije podrazumijeva utvrđivanje validnosti studijskih programa, njihove primjerenosti važećim standardima kvaliteta i tržištu rada i sertifikat obezbjeđivanja prava ustanovi na dodjelu stepena obrazovanja, zanimanja i profesije.

Obrazovna djelatnost na ustanovama visokog obrazovanja ostvaruje se kroz akademske i primijenjene studijske programe, kao i kroz raznovrsne programe stručnog usavršavanja i osposobljavanja. Struktura visokoobrazovnog sistema bazirana je na tri ciklusa i to: dodiplomski (osnovne studije), postdiplomski i doktorski.

Studije na ustanovama visokog obrazovanja ostvaruju se u skladu sa pravilima studiranja zasnovanim na Evropskom sistemu transfera kredita (ECTS – European Credit Transfer System).

Trajanje studija

- Osnovne akademske studije (3 ili 4 godine)
- Osnovne primijenjene studije (3 godine)
- Postdiplomskie specijalističke studije (3+1 godina)
- Postdiplomskie magistarske studije (3+2 godine; 3+1+2; 4+1 godina)
- Doktorske studije (3 godine)

Studije medicinskih nauka traju duže. Studije stomatologije traju 5 godina, a studije medicine 6 godina.

Upis

Upis na studijski program vrši se na konkurentskoj osnovi, u skladu sa rezultatima postignutim na završetku i tokom srednjeg obrazovanja, nakon sprovedenog postupka rangiranja, a saglasno sa statutom javne ustanove. Za određene programe mogu se odrediti i dodatni uslovi. Status studenta stiče se upisom na studijski program. Studenti i ustanova zaključuju ugovor o studiranju, u kome se definišu međusobna prava i obaveze. Pravo upisa na studijski program imaju i strani državljanji.

Ispiti

Ocjenjivanje i vrednovanje znanja studenata vrši se u skladu sa ECTS skalom ocjena: A, B, C, D, E i F. Prelazne ocjene su: A, B, C, D, E i prema ECTS imaju sljedeće značenje: A (odličan), B (vrlo dobar), C (dobar), D (zadovoljavajuć), E (dovoljan) i F (nedovoljan).

- 5) utvrđuje mjerila za ocjenjivanje studijskih programa sa stanovišta njihove usklađenosti sa profesionalnim potrebama i međunarodne uporedivosti;
- 6) preduzima periodične kontrole kvaliteta licenciranih ustanova i izdaje sertifikat o počinjaju akreditaciji, akreditaciji ili reakreditaciji;
- 7) vrši i druge poslove propisane ovim zakonom i aktom o osnivanju Savjeta.

Organizacija i način rada Savjeta bliže se uređuje poslovnikom o radu.
