Predlaže se i da mentor bude doc. dr Dijana Vučković, i to iz tri razloga:

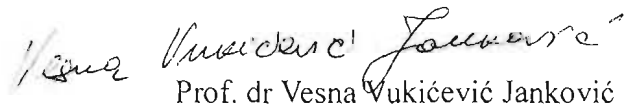
- planirano istraživanje zasnovano je u većoj mjeri na metodologiji društvenih nauka, koju je profesorka Vučković uspješno primjenjivala u mnogim radovima (prvenstveno se misli na tehnike dubinskog intervjua, fokus-grupne diskusije i ankete);
- profesor Arsenijević je eksterno angažovan nastavnik, pa bi obim njegove stručne pomoći kandidatu ipak bio ograničen;
- ugovor o stipendiranju koji je kandidat sklopio s Ministarstvom nauke Crne Gore i Univerzitetom Crne Gore obavezuje nas na izbor mentora koji će stalno pratiti istraživačke aktivnosti stipendiste.

S obzirom na to da kandidat planira istraživanje koje zalazi u dvije naučne oblasti: oblast sociolingvistike i oblast metodike nastave maternjeg jezika. Zbog multidisciplinarnosti teme predlaže se imenovanje mentora i komentora.

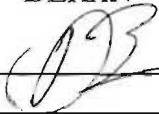

dr Dijana Vučković, docent Univerziteta Crne Gore

Rodena 1972. godine u Bileći (Bosna i Hercegovina, SFRJ), gdje je završila osnovnu i srednju školu. Diplomirala na Studijskom programu za obrazovanje učitelja, na Filozofskom fakultetu u Nikšiću (prosječna ocjena 9,31), magistrirala 2005. godine (prosječno 9,87) i doktorirala 2009. godine na Učiteljskom fakultetu Univerziteta u Beogradu. Doktor je didaktičko-metodičkih nauka i docent Univerziteta Crne Gore.

Diplomski rad, magistarsku tezu i doktorsku disertaciju Vučković je radila iz metodike nastave srpskog jezika i književnosti. Izabrana je u zvanje docenta za oblast metodike nastave maternjeg jezika i književnosti na Studijskom programu za obrazovanje učitelja i oblast metodika vaspitno-obrazovnog rada na Studijskom programu za predškolsko vaspitanje. Vučković izvodi nastavu iz predmeta Teorije učenja na magistarskim studijama, a od akademske 2018/19. godine povjeren joj je predmet iz oblasti metodologije naučnoistraživačkog rada u drugom ciklusu studija, za šta su je preporučili radovi objavljeni u međunarodnim bazama podataka (SSCI i A&HCI), a naročito raznovrsna metodologija koju primjenjuje u istraživanju.

Studijske 2003/04. godine angažovana je od strane Filozofskog fakulteta kao honorarni saradnik u nastavi za predmet Metodika nastave srpskog jezika i književnosti na Studijskom programu za obrazovanje učitelja. Radni odnos na Filozofskom fakultetu zasnovala je 1. novembra 2005. godine u svojstvu saradnika u nastavi za predmet Metodika nastave srpskog jezika i književnosti na Studijskom programu za obrazovanje učitelja. U zvanje docenta na Filozofskom fakultetu izabrana je 11. februara 2010. godine (Bilten Univerziteta Crne Gore br. 251). U isto zvanje reizabrana je novembra 2015. godine (Bilten UCG br. 353)<sup>1</sup>.

Od studijske 2008/09. godine rukovodilac je Studijskog programa za obrazovanje učitelja na Filozofskom fakultetu u Nikšiću. Bila je članica Vijeća Vijeća društvenih nauka Senata Univerziteta Crne Gore u periodu 2014–2018. godine. Članica je Centra za studije i kontrolu kvaliteta i Odbora za monitoring magistarskih studija Univerziteta Crne Gore od 2017. godine.

Učestvovala je u brojnim međunarodnim projektima. Između ostalog, riječ je o projektima Savjeta Evrope: *Travel Pass to Democracy* (2013), *Teaching Controversial Issues* (2015), *Fostering a Democratic School Culture in Montenegro* (2018). Aktivno je učestvovala i u nacionalnim i bilateralnim projektima poput: *Demokratija i obrazovanje* (Civitas Montenegro centar), *Liderstvo i omladinski rad u zajednici* (Filozofski fakultet i Forum MNE, Univerzitet u Jonkopingu, Švedska), *Nasilje među vršnjacima* (Civitas Montenegro centar), *Vaspitanje tolerantne ličnosti* (UNESCO katedra na Filozofskom fakultetu), *Preduzetničko učenje na neekonomskim fakultetima* (SEECEL, Zagreb). Bila je članica užeg tima Univerziteta Crne Gore za rad na projektu TEMPUS DEVCORE (*Development of Learning Outcomes Approach – Way to a Better Comparability, Recognition, and Employability at the Labour Market, capacity building project*), a od novembra 2017. godine angažovana je u radu na ERASMUS+ Re@WBC projektu (*Enhancement of HE Research Potential Contributing to Further Growth of the WB Region*). Članica je međunarodne organizacije *Athens Institute for Education and Research (ATINER)*, čije je sjedište u Grčkoj.

Sertifikovani je Montessori pedagog od 2016. godine. Autorka je i realizatorica nekoliko programa stručnog usavršavanja nastavnika u okviru sektora Profesionalni razvoj nastavnika na nivou škole (PRNŠ, podaci dostupni na <http://www.zzs.gov.me>). Recenzentkinja je u Zavodu za udžbenike Crne Gore i koautorka udžbeničkog kompleta za književnost za drugi razred osnovne škole. Koautorka je Brajevog bukvara (2016) i članica redakcije časopisa *Učenje i nastava*.

Učestvovala je u radu brojnih međunarodnih naučnih i stručnih konferencija i skupova. Radovi koje je dr Vučković do sada publikovala svjedoče o dobrom poznavanju metodologije i o vještini kreiranja metodološkog okvira istraživanja. Teme kojima se bavi aktuelne su na lokalnom i na širem planu. Neki od radova urađeni su kvalitativnom metodologijom, a realizovala je i opsežna kvantitativna istraživanja. U naučnoistraživačkom radu Vučković koristi raznovrsne metode, tehnike i instrumente prikupljanja i obrade podataka. Instrumente uglavnom kreira za potrebe konkretnih istraživanja. Solidan je poznavalac statistike u društvenim istraživanjima, a za obradu podataka najčešće koristi softverski paket SPSS.

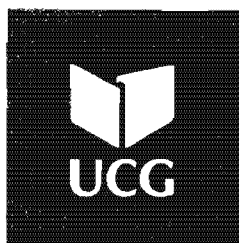

### **1. Vertragsparteien**

**Karl-Franzens-Universität Graz**, vertreten durch die Rektorin, Frau Univ.-Prof. Dr. Christa Neuper, 8010 Graz, Universitätsplatz 3, als **Arbeitgeberin** und **Herrn Prof. Boban Arsenijevic, PhD**, geb. am **05.11.1974**, Adresse: **SRB- 18000 Nis, Jablanicka 4**, als **Arbeitnehmer**.

### **2. Beginn und Dauer des Arbeitsverhältnisses**

2.1 Das Arbeitsverhältnis beginnt am **01.10.2017** und wird auf unbestimmte Zeit abgeschlossen.

2.2. Es wird festgehalten, dass ein gültiger Aufenthaltstitel Voraussetzung für eine Beschäftigung in Österreich ist. Der Arbeitnehmer ist verpflichtet an der rechtzeitigen Bewilligung mitzuwirken. - Lehrveranstaltungen, insb Pflichtlehrveranstaltungen, nach Maßgabe des sich aus dem Studienrecht ergebenden Bedarfs nach dem jeweiligen Standard in Forschung und Lehre mit den entsprechenden Methoden durchzuführen und Prüfungen abzuhalten. Zur Lehrverpflichtung gehört auch die Vorbereitung auf die

Lehrveranstaltungen sowie die Betreuung der Studierenden im Rahmen der Lehrveranstaltungen;

## **6. Entlohnung**

6.1 Als Universitätsprofessor gem § 98 UG ist der Arbeitnehmer gem § 48 Universitäten-KV in die Verwendungsgruppe A 1 einzureihen. Das kollektivvertragliche Mindestentgelt (Grundgehalt) beträgt daher **€ 68.475,40** brutto/Jahr (Wert 2017). Im Rahmen der Berufung wird jedoch ein das Grundgehalt übersteigendes Jahresbruttoentgelt in Höhe von **€ 85.000,-** vereinbart, das sich aus 12 Monatsentgelten jeweils in Höhe von **€ 6.071,43** sowie 4 Sonderzahlungen, jeweils im Ausmaß des halben für den Auszahlungsmonat zustehenden Entgelts zusammensetzt. Mit dem Entgelt sind das gem Pkt 5.2 vereinbarte Ausmaß an Lehre sowie sämtliche Mehrleistungen des Arbeitnehmers in qualitativer und quantitativer Hinsicht abgegolten. 9.2 Die Arbeitgeberin ist gem § 10 Abs 2 Universitäten-KV berechtigt, die von ihr über die Gehaltskosten hinaus aufgewendeten Kosten für eine überwiegend von ihr finanzierte Ausbildung zurückzuverlangen, wenn diese Kosten € 2.000,00 übersteigen, und der Arbeitnehmer innerhalb von vier Jahren nach Abschluss dieser Ausbildung durch vorzeitigen Austritt ohne wichtigen Grund, durch Selbstkündigung oder durch eine von ihm verschuldete Entlassung aus dem Arbeitsverhältnis ausscheidet.

Der Rückersatz verringert sich mit jedem vollen Monat, um den das Arbeitsverhältnis nach Abschluss der Ausbildung weiter besteht, um zwei Prozent der von der Arbeitgeberin aufgewendeten Kosten.

## **10. Nebenbeschäftigung**

Es gilt § 12 Universitäten-KV. Der Arbeitnehmer ist insbesondere verpflichtet, der Arbeitgeberin jede beabsichtigte erwerbsmäßige Nebenbeschäftigung und deren wesentliche Änderung sowie die Tätigkeit im Vorstand, Aufsichtsrat oder Verwaltungsrat einer auf Gewinn gerichteten juristischen Person zu melden. Weiters hat der Arbeitnehmer jede Nebenbeschäftigung zu unterlassen, durch deren Ausübung arbeitsvertragliche Verpflichtungen oder sonstige wesentliche dienstliche Interessen der Universität beeinträchtigt werden.

## **11. Verschwiegenheitspflicht/Datenschutz**

Der Arbeitnehmer hat über alle innerbetrieblichen Angelegenheiten und alle ihm in Ausübung seiner Tätigkeit bekannt gewordenen Umstände, an deren Geheimhaltung die Arbeitgeberin ein dienstliches Interesse hat, strengste Verschwiegenheit zu bewahren. Diese Verschwiegenheitspflicht besteht auch nach Beendigung des Arbeitsverhältnisses weiter. Der Arbeitnehmer ist verpflichtet, das Datengeheimnis iSd § 15 DSG 2000 idgF zu wahren: Personenbezogene Daten, die ihm im Zusammenhang mit seinem Arbeitsverhältnis anvertraut wurden oder zugänglich geworden sind, sind geheim zu halten. Daten dürfen nur nach ausdrücklicher Anordnung der Arbeitgeberin übermittelt werden. Der Arbeitnehmer verpflichtet sich, das Datengeheimnis auch nach Beendigung des Arbeitsverhältnisses einzuhalten.

## **12. Dienstleistungen und Verwertung von geistigem Eigentum**

In Bezug auf Dienstleistungen und die Verwertung von geistigem Eigentum wird auf die Regelungen des § 106 UG verwiesen.

## **13. Dienstreisen**

13.1 Der Arbeitnehmer ist verpflichtet, auf Anordnung der Arbeitgeberin Dienstreisen zu unternehmen.

13.2 Es gelten die Bestimmungen der Betriebsvereinbarung über die Voraussetzungen und Modalitäten sowie die Höhe der Abgeltungen für Dienstreisen gem § 4 Z 19 iVm § 62 Abs 3 Universitäten-KV sowie der Betriebsvereinbarung über die Gewährung von Reisekostenzuschüssen an das wissenschaftliche Universitätspersonal gem § 4 Z 20 iVm § 62 Abs 4 Universitäten-KV.

## **14. Beendigung**

14.1 Für die Kündigung des Arbeitsverhältnisses gelten die §§ 21f Universitäten-KV sowie § 20 AngG.

14.2 Das Arbeitsverhältnis kann unter Berücksichtigung der Bestimmungen der §§ 21f Universitäten-KV von beiden Seiten zum Letzten eines jeden Kalendermonats durch Kündigung beendet werden. Nach dem vollendeten fünften Dienstjahr ist der Kündigungstermin für die Arbeitgeberin das jeweilige Quartalsende. Sowohl von Seiten der Arbeitgeberin als auch von Seiten des Arbeitnehmers sind die Kündigungsfristen des § 20 Abs 2 AngG einzuhalten. Die Kündigung bedarf zu ihrer Wirksamkeit der Schriftform.

14.3 Für die vorzeitige Auflösung des Arbeitsverhältnisses aus wichtigem Grund gelten die Bestimmungen der §§ 25ff AngG iVm § 23 Universitäten-KV. Entlassung und vorzeitiger Austritt bedürfen zu ihrer Wirksamkeit der Schriftform.

#### 15. Sonstige anzuwendende Vorschriften

Das Arbeitsverhältnis unterliegt insbesondere den für das wissenschaftliche Personal geltenden personalrechtlichen Bestimmungen des Universitätsgesetzes (UG), dem Angestelltengesetz (AngG) sowie dem Kollektivvertrag für die ArbeitnehmerInnen der Universitäten (Universitäten-KV; abrufbar im Intranet der Universität).

#### 16. Betriebliche Vorsorgekasse

Es gelten die Bestimmungen des BMSVG. Beitragsleistungen der Arbeitgeberin im Sinne des BMSVG werden an die APK Vorsorgekasse AG, 1030 Wien, Thomas-Kleist-Platz 1, überwiesen. Sämtliche Forderungen iSd BMSVG sind daher gegenüber der APK Vorsorgekasse AG geltend zu machen.

#### 17. Personalevidenz

Der Arbeitnehmer ist verpflichtet, der Universität alle Änderungen seiner Personalien (zB Name, Familienstand) und seiner Wohn- und Zustelladresse unverzüglich bekannt zu geben.

#### 18. Verfall von Ansprüchen

Für die Geltendmachung von Ansprüchen aus dem Arbeitsverhältnis gelten die Bestimmungen des § 64 Universitäten-KV.

#### 19. Schriftform

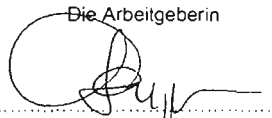

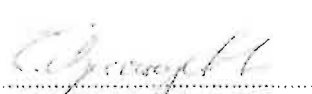
