Academy of Applied Studies Belgrade is open for admission of nominated academic staff for mobility within the Erasmus+ KA171 program in the summer semester of the academic year 2023/24.

NOTE: Working language of the mobility is English.

Minimum recommended language instruction level: **English B2** according to CEFR.

Total number of funded staff mobility is **three (3): two (2) from Albania and one (1) from Montenegro.**

DURATION OF THE MOBILITY

The duration of teaching mobility should be in accordance with the Mobility agreement. The expected duration of staff mobility is five days. In order to be eligible for funding, a minimum of **8 hours of teaching** must be provided for periods of up to 7 days (including travelling days and/or any public holidays or days before). In the case of “**combined**” mobility (**teaching/training**), the minimum number of teaching hours is halved (**4 hours of teaching** for periods of up to 7 days). **BEFORE the mobility start** academic staff member from the partner HEI will establish communication with his/her counterpart at AASB to arrange teaching/training activities. Eligible activities for training include: a short secondment period, job-shadowing, attendance at workshops/courses, attendance at a staff training week. It could be built around the transfer of knowledge and good practice, acquiring of new practical skills, discovery of new ideas for teaching/learning etc.

APPLICATION PROCESS



ACADEMY OF APPLIED STUDIES BELGRADE

- Read the information of the Public Call carefully as to the requirements for application submission.
- Prepare complete documentation and submit the application to the authority responsible (E+coordinator) for conducting the Public Call at the Universiteti fan s noli Korce or Javna Ustanova Univerzitet Crne Gore Podgorica.

SUBMITTING AN APPLICATION:

The application (documentation in pdf) for the Call needs to be sent to a responsible person at the Universiteti fan s noli Korce, before the deadline to bstavre@unkorce.edu.al or to a responsible person at the Javna Ustanova Univerzitet Crne Gore Podgorica, before the deadline to mobilnostfth@ucg.ac.me.

Additional documentation, if requested by the Academy of Applied Studies Belgrade, is a mandatory part of the application.

NOTE: After applications are submitted to the person(s) in charge at the Universiteti fan s noli Korce or Javna Ustanova Univerzitet Crne Gore Podgorica, candidates' nomination is sent to the Academy of Applied Studied Belgrade. The final decision on the academic staff members chosen to participate in the Erasmus+ KA171 Programme is made by the AASB International Mobility Committee.

All candidates are reminded that untimely, incomplete and unauthorized applications will not be considered.

ELIGIBLE PERIOD FOR THE MOBILITY

The eligible period for the KA171 mobility under this call is the **summer semester of the academic year 2023/2024**.

4. Consent to carry out mobility obtained by academic host at AASB, in the form of an invitation letter addressed to the candidate or in email communication with the candidate.

SELECTION RESULTS

The selection results will be communicated by email to candidates and published on the institutional websites **by 15 April 2024**. An appeal against the selection results of the Call for the selection of candidates can be submitted to Erasmus+coordinator within 3 working days from the date of publication of the results.

SELECTION CRITERIA

Candidates are ranked according to the number of points achieved. Selection criteria for staff



are the following:

- a proposal for a Mobility agreement (30 pts)
- academic career (30pts)
- participation in international activities and contribution to Erasmus+ activities (20pts)
- certificate of English language proficiency (20 pts)

Note on taxation: *tax requirements will be paid in line with the requirement of the Albania or Montenegro Revenue Authority.*

Double funding: *The participant cannot receive financial support from the funds of the Erasmus+ mobility program if the participant's stay abroad is additionally financed by funds originating from other programs and/or projects of the European Union*

TRAVEL COSTS

A member of staff who is selected for a mobility project in the field of higher education is entitled to travel support in the total amount of **EUR 180** for a round trip according to the Erasmus+ Program Guide and Distance Calculator: <https://erasmus-plus.ec.europa.eu/resources-and-tools/distance-calculator>

HEALTH INSURANCE

The cost of mandatory health insurance during mobility is not covered by the Erasmus+ KA171 grant. Selected candidates are obliged to obtain adequate international travel health insurance to be covered during their stay in the Republic of Serbia.

VISA

Selected candidates are obliged to obtain adequate visa for the whole duration of their stay in the Republic of Serbia.

PROVING THE STATUS OF A PERSON WITH DISABILITY:

Persons with disabilities/chronic conditions or physical impairments, as well as persons accompanying them, may exercise the right to reimbursement of eligible real costs incurred during the mobility period, by submitting additional documentation, namely:

- Declaration form for participants in mobility with disability - submitted at the time of registration of participants to the Call.
- A document issued by the National Employment Service or another government authority that confirms the health condition. If not applicable, it is necessary to provide a report of a specialist (a doctor, psychologist, etc.) confirming the health condition – submitted at the time of registration of participants to the Call.
- Invoices for the real costs incurred, with the indicated description of the service/goods, amount, currency, invoice date, as well as proof of payment-delivered after the mobility is approved and carried out.

The medical documentation from the previous paragraph must be issued by the competent health institution and must not be older than six months. It is necessary to be able to conclude on the basis of the medical report how the disability/health condition affects the learning outcomes and daily functioning of the candidate.
