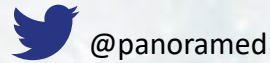

THE ROLE OF THE EMILIA-ROMAGNA REGION

The Emilia-Romagna Region is in charge of the Work package n°4, "Methodologies and evaluation" to define the methodologies that applies within the thematic working groups, in order to support the implementation of the activities and the definition of the strategic issues for new projects.

The involvement of the Emilia-Romagna Region, which has always been committed to the cohesive and sustainable development of the Mediterranean area, started during the 2007-2013 period of the Med Programme. The activities are carried out jointly with Art-er (in-house company of the Region).

By Panoramèd, the Region also aims at increasing and highlighting its participation in some of the main networks and initiatives active in the Mediterranean region, such as CPRM, Bluemèd Initiative, Vanguard Initiative, West Med Initiative, consistently with the Adriatic Programme and the Eusair macroregional strategy.

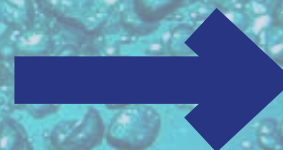
