Background

The EU4Green project started in January 2022 and has the overall objective to enhance the Western Balkans transition to modern, resource-efficient and competitive economies and the specific objective to support the Western Balkans in the implementation of the Green Agenda, thus achieving their commitment to transforming their economies on a more sustainable path and reaching climate neutrality by 2050.

Furthermore, it is our EU4green mandate to actively think and implement activities based on the integration of environment and climate as well as green skills necessary for the green transformation in ongoing reforms of the education systems. In order to drive a green, sustainable economy in the WBR, it is important to improve the quality and relevance of formal education (links to teacher standards, teacher training and continuous professional development) and to build additional competencies outside of formal education. EU4Green encourages and will develop tailor-cut Micro-credential modules, as one way to support modernization of curricula and promote equitable and inclusive education at all levels in WB6 economies.

Specific objectives of the 1st Regional Education Workshop

- Articulation of needs for green skill development (educational level, topics, regions, specific target groups...)
- Identification of regulatory requirements, accreditation and admission of potential micro-credentials (Manual for Micro-credentials, Good practice examples)
- Collection of interest and commitment to co-develop Micro-credential portfolios for 2 pilot initiatives in selected economies or specific regions
- Any other important items to support the implementation of EU4Green and the Green Education activities.
